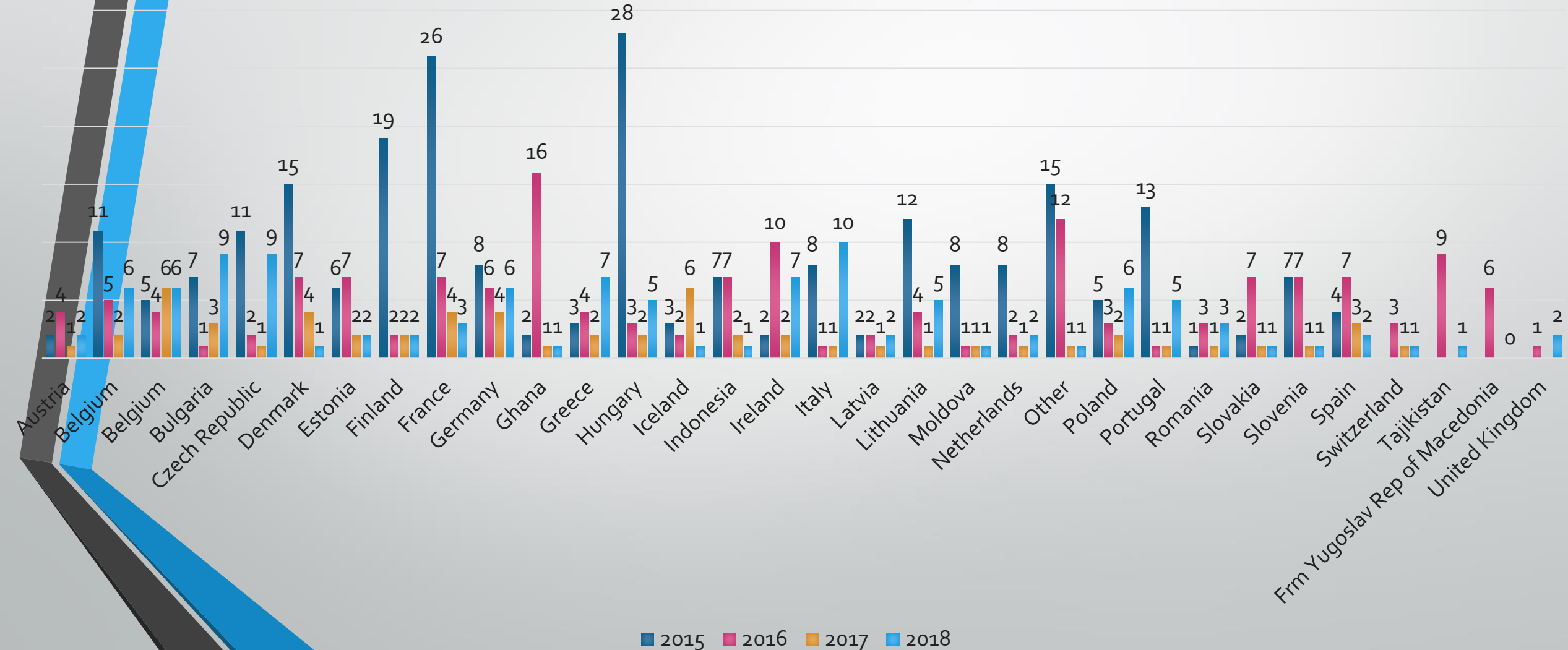

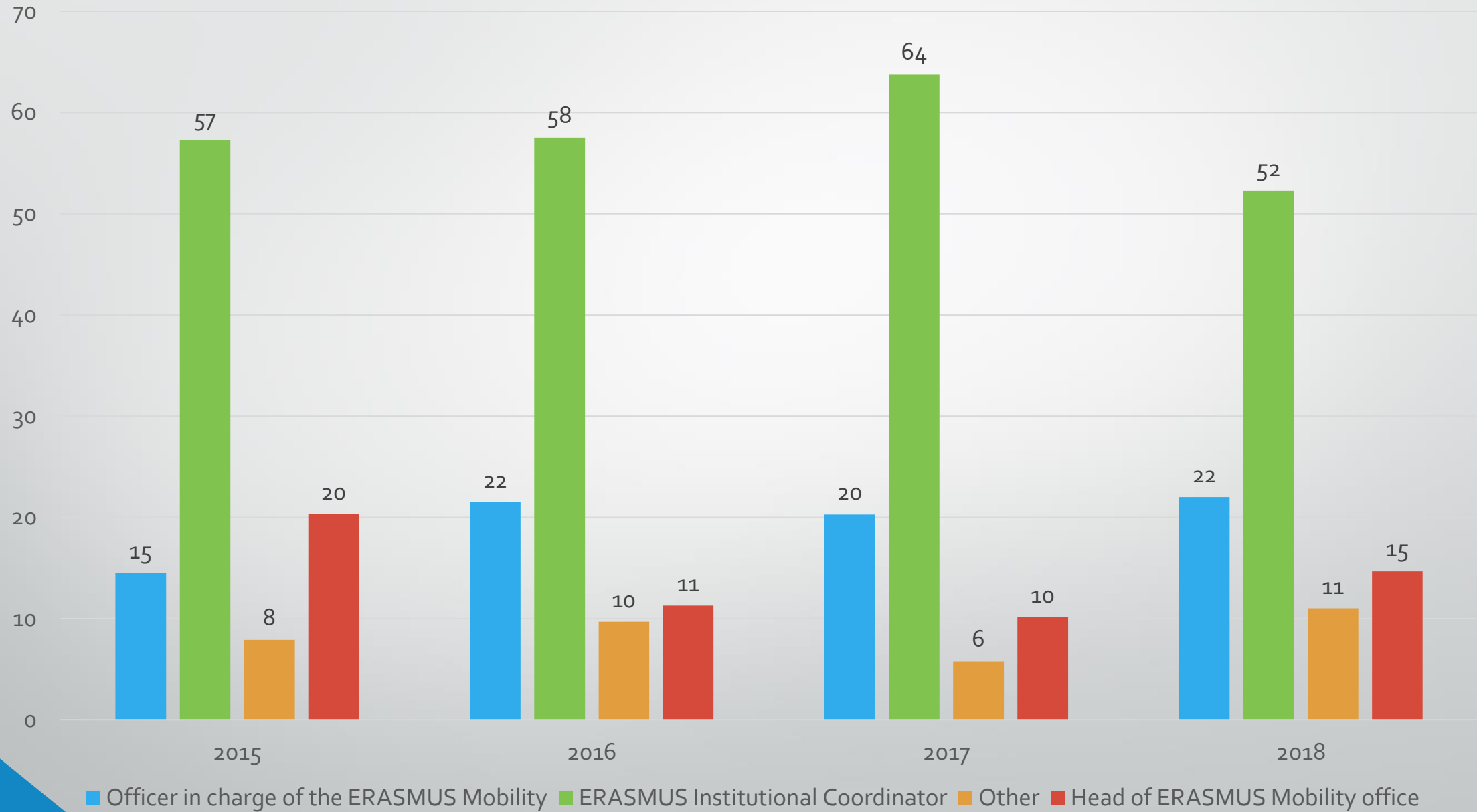


SURVEY DEMOGRAPHICS

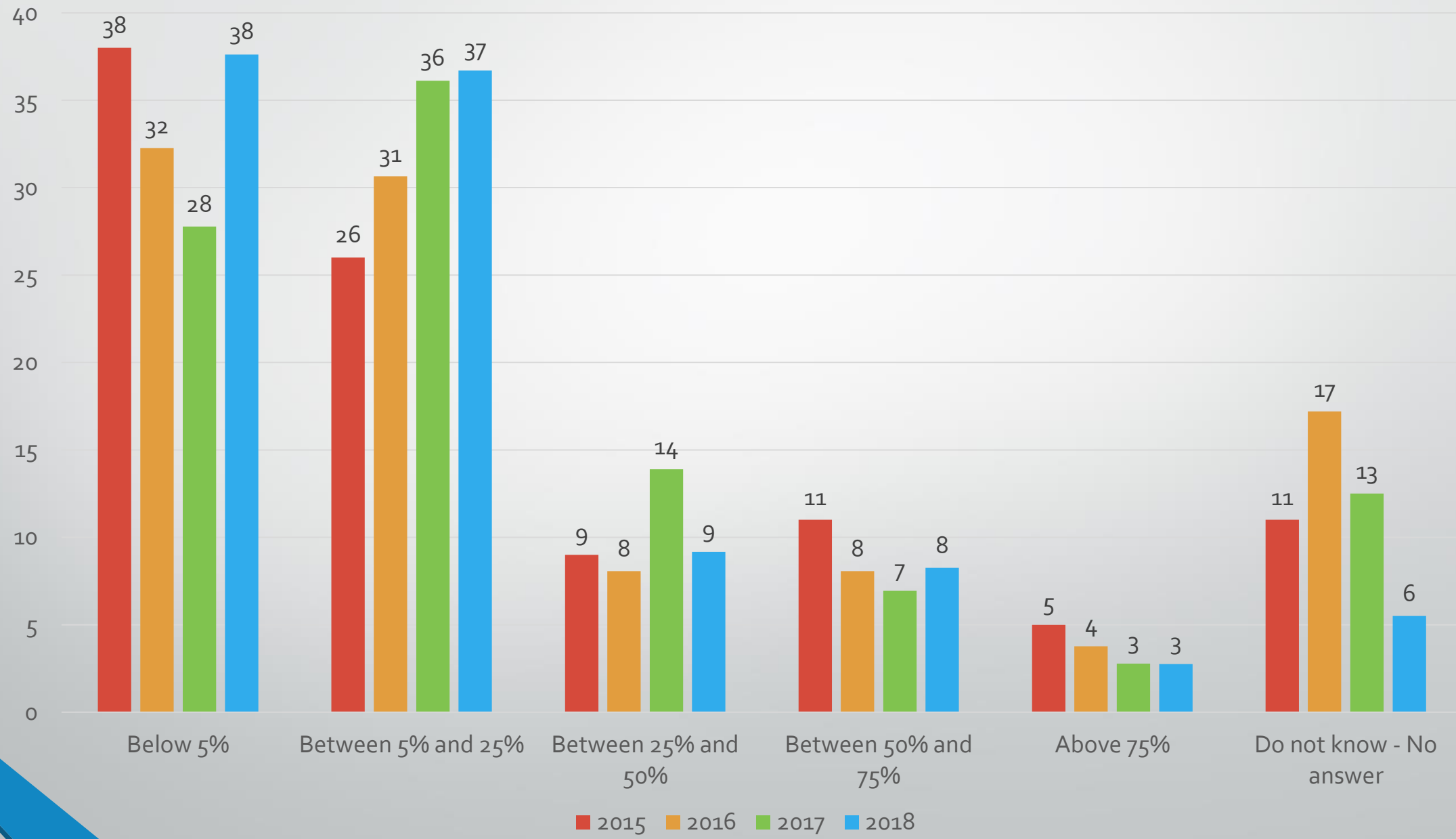

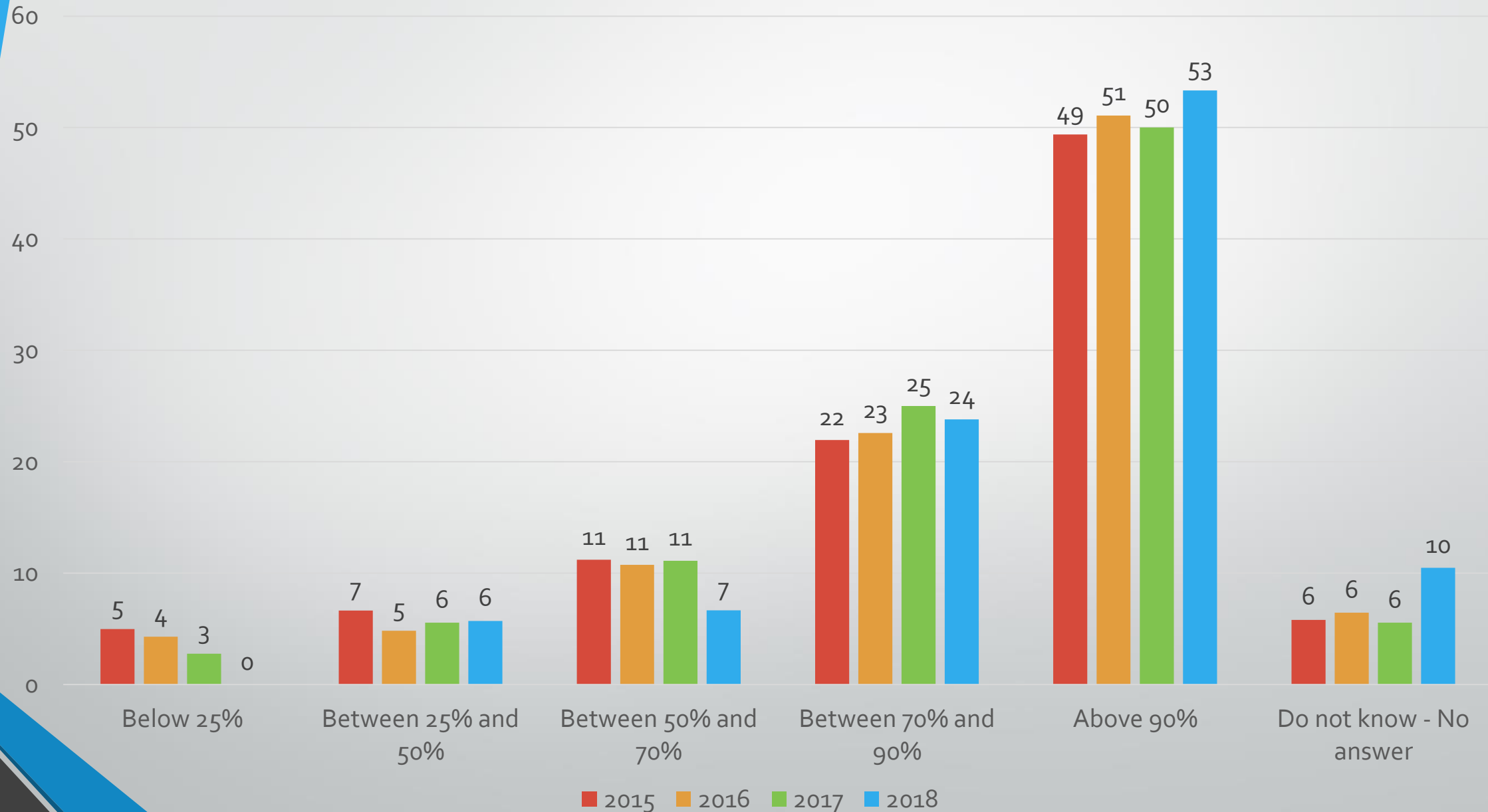

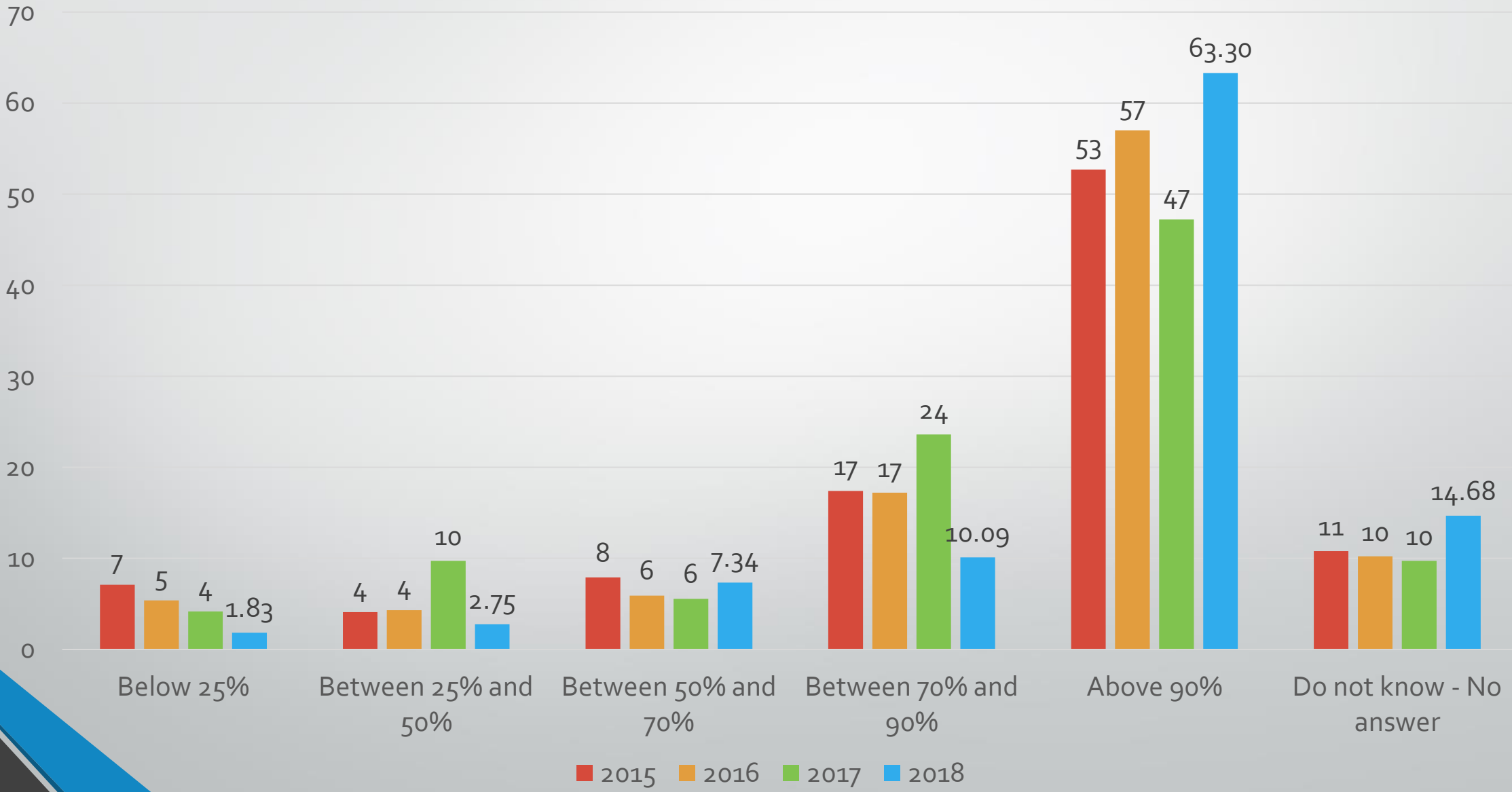

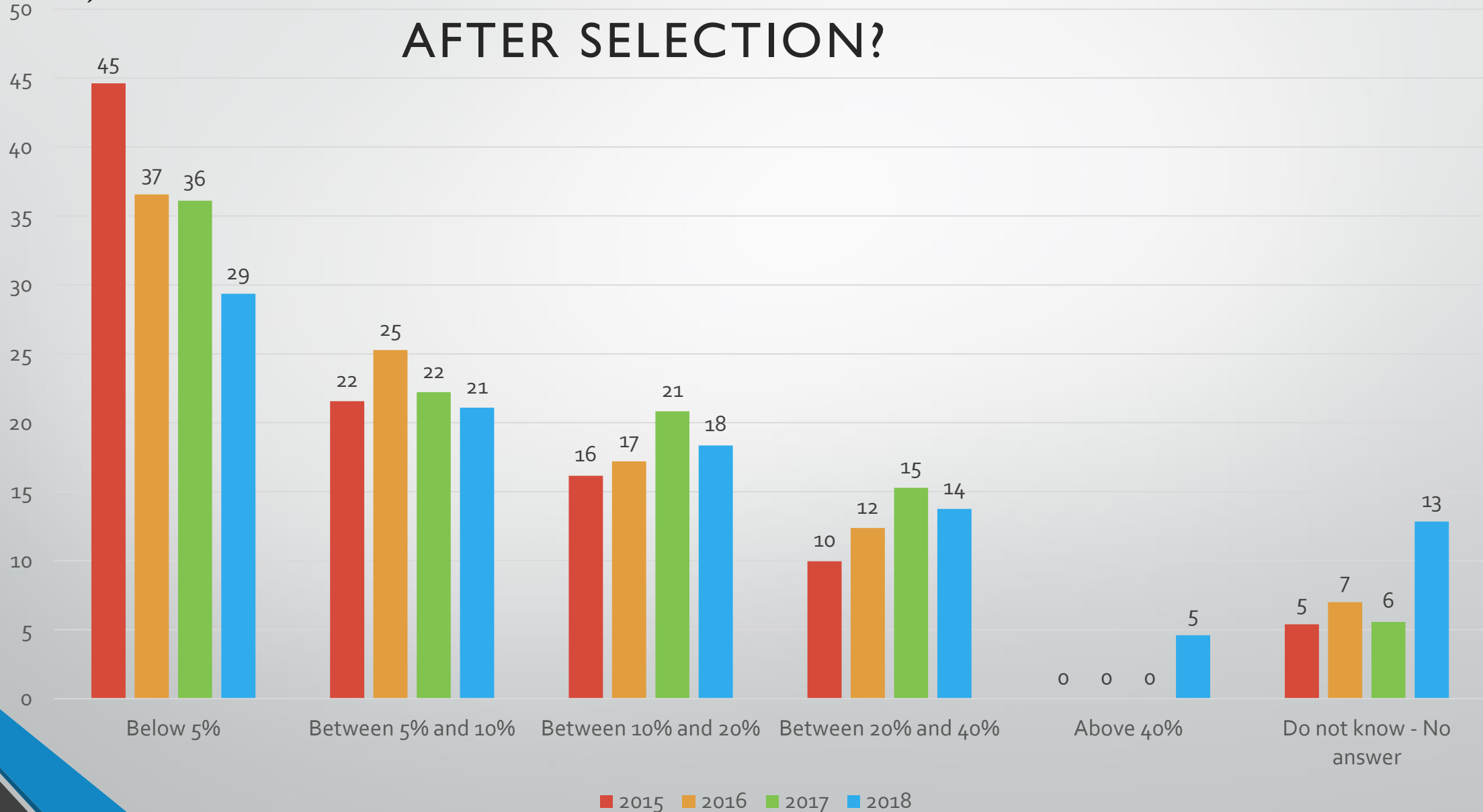

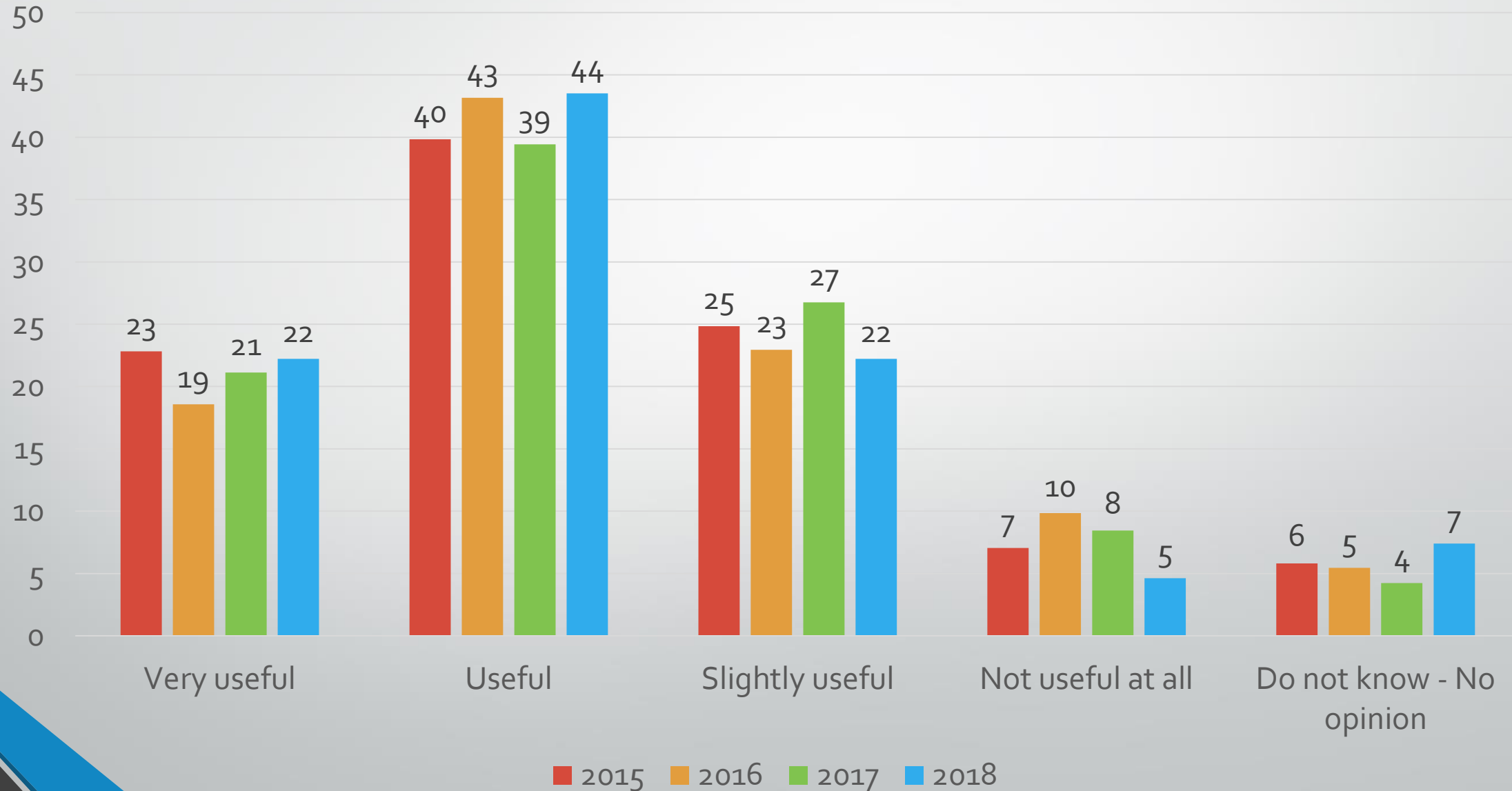

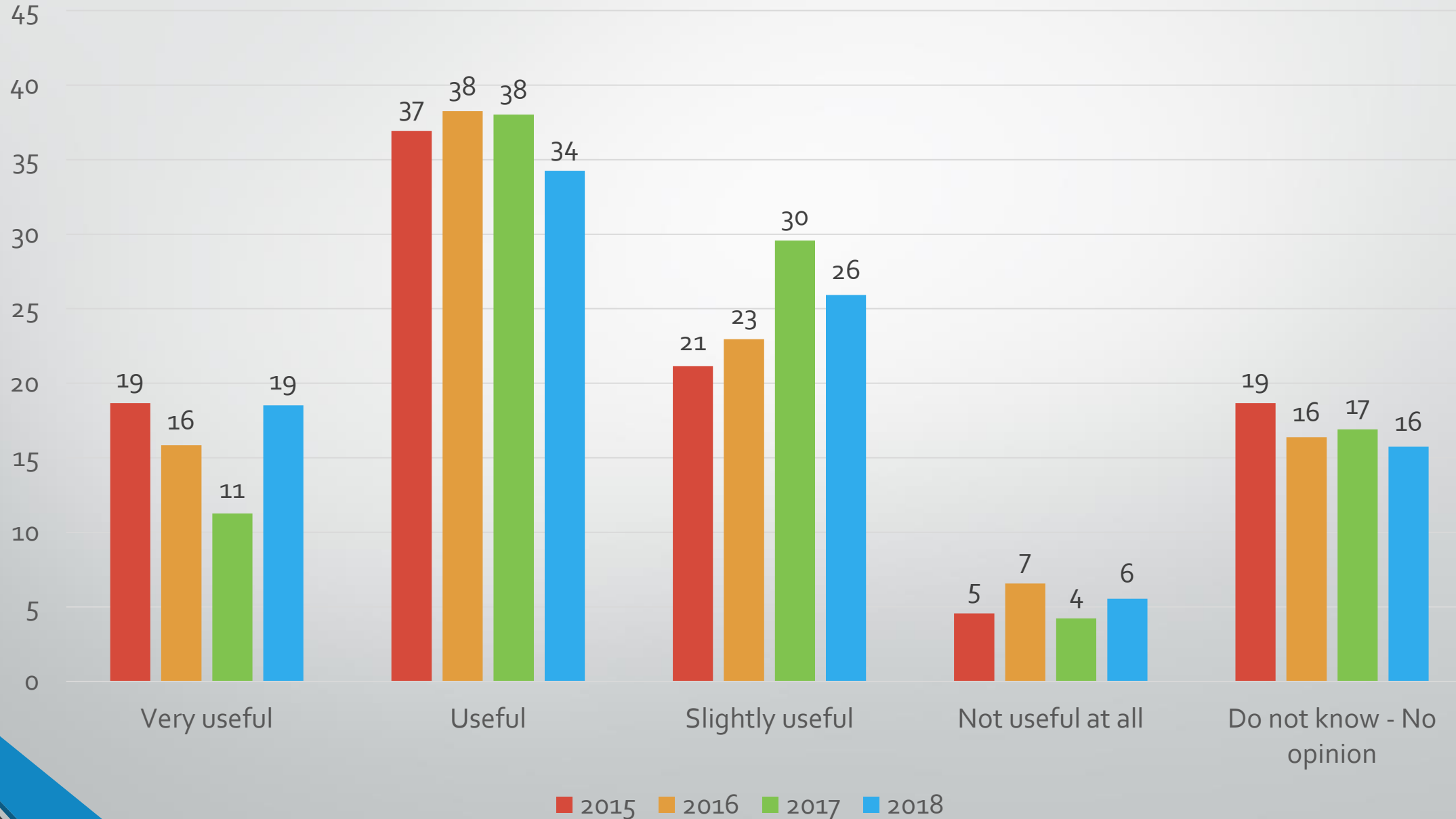

B3.1. IN YOUR OPINION, HOW USEFUL IS THE OLS LANGUAGE ASSESSMENT?



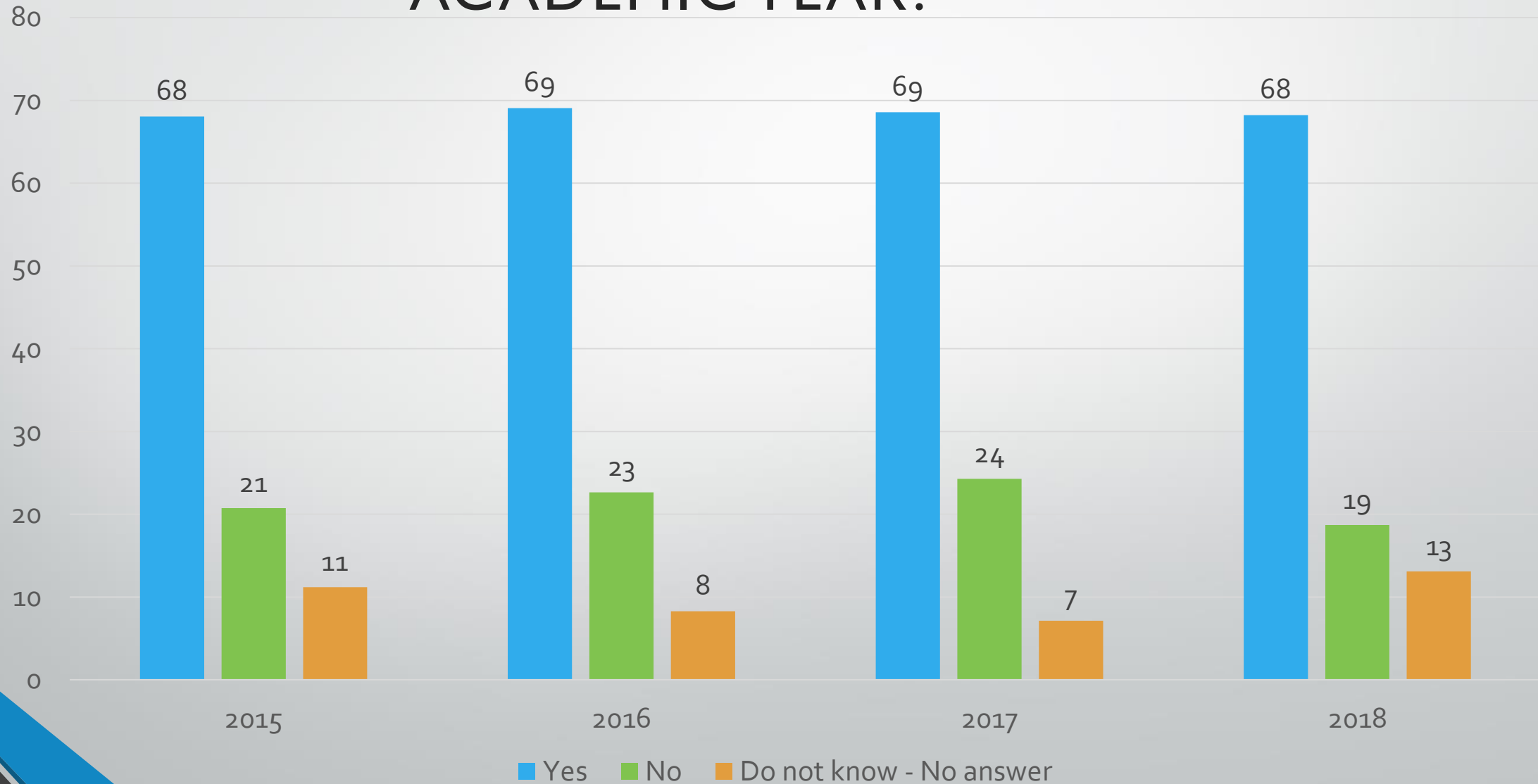

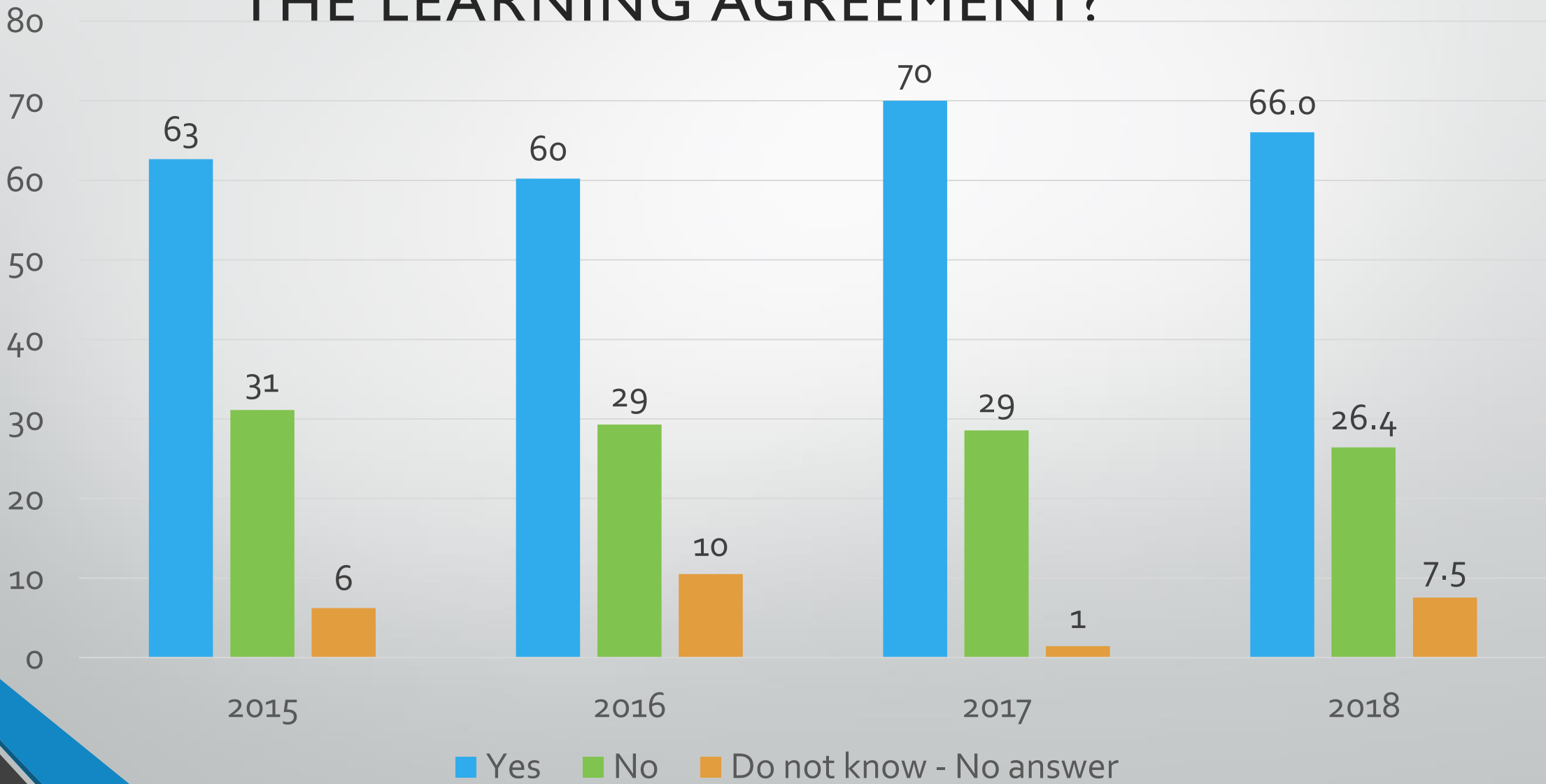

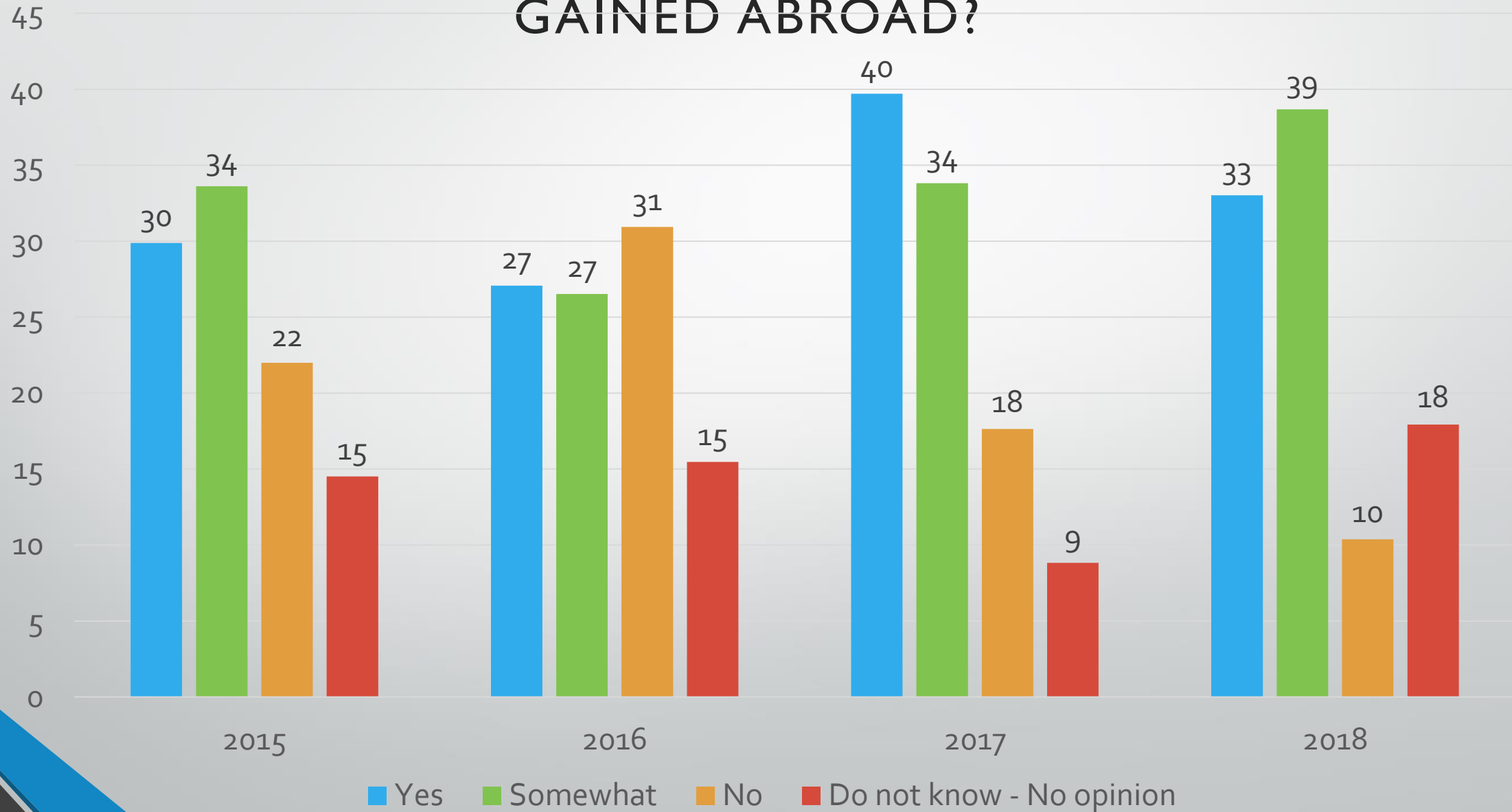

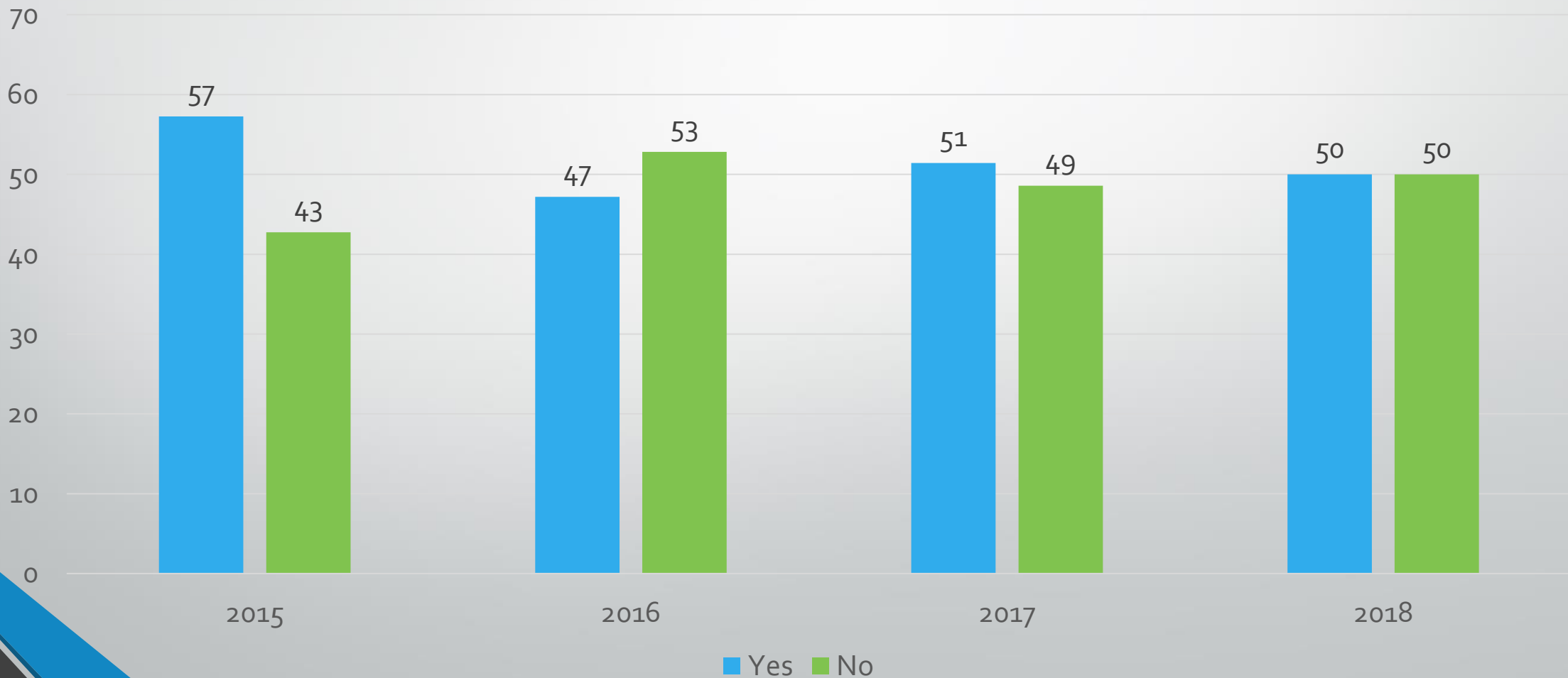

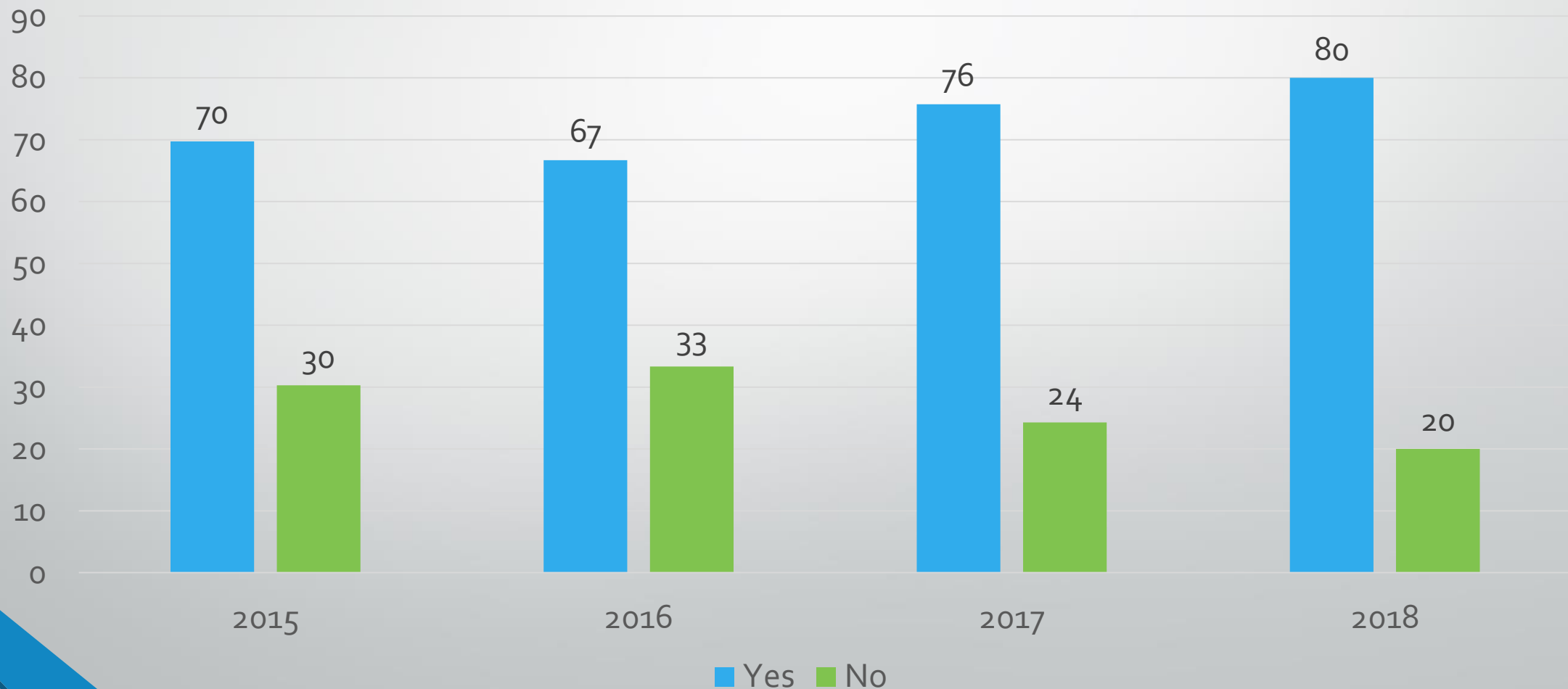
B6.1. DO YOU ENCOURAGE YOUR PARTICIPANTS TO USE THE EUROPASS MOBILITY CERTIFICATE?



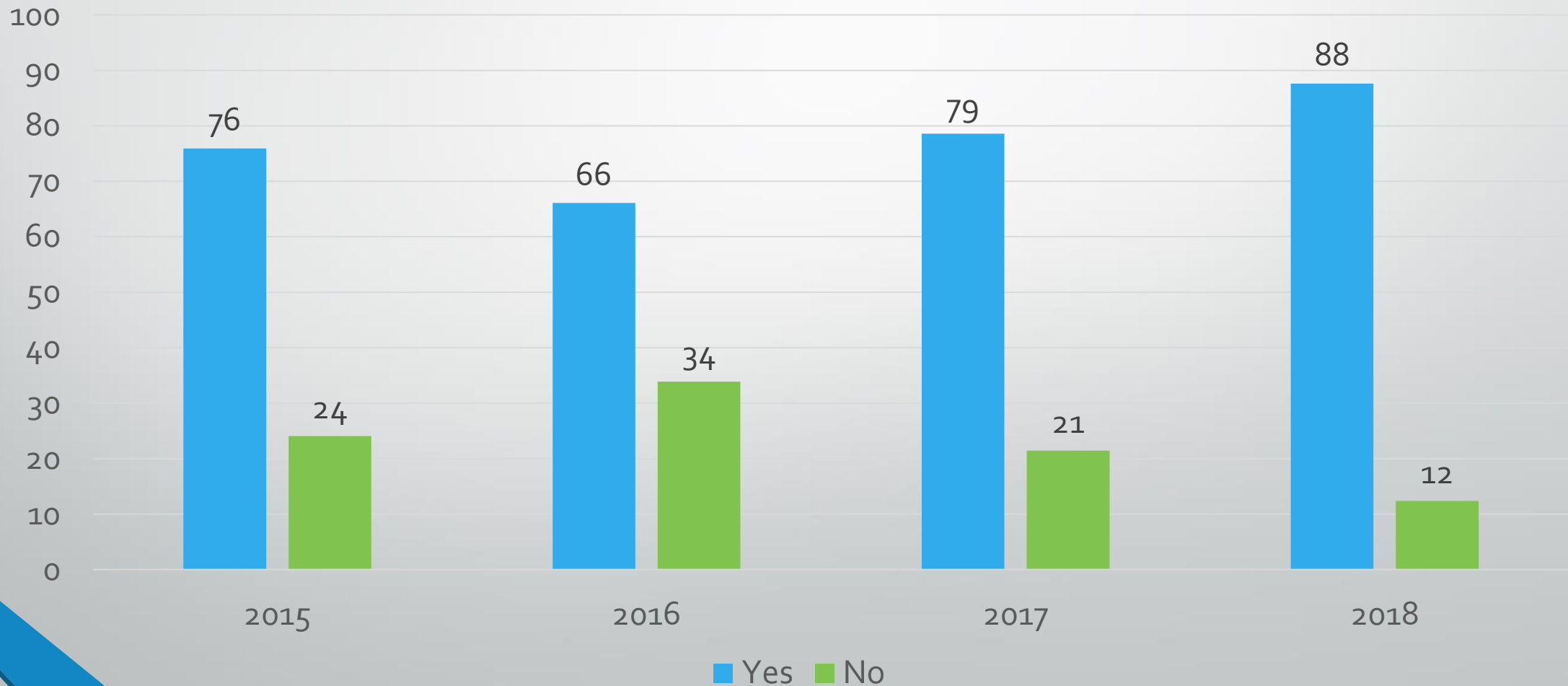

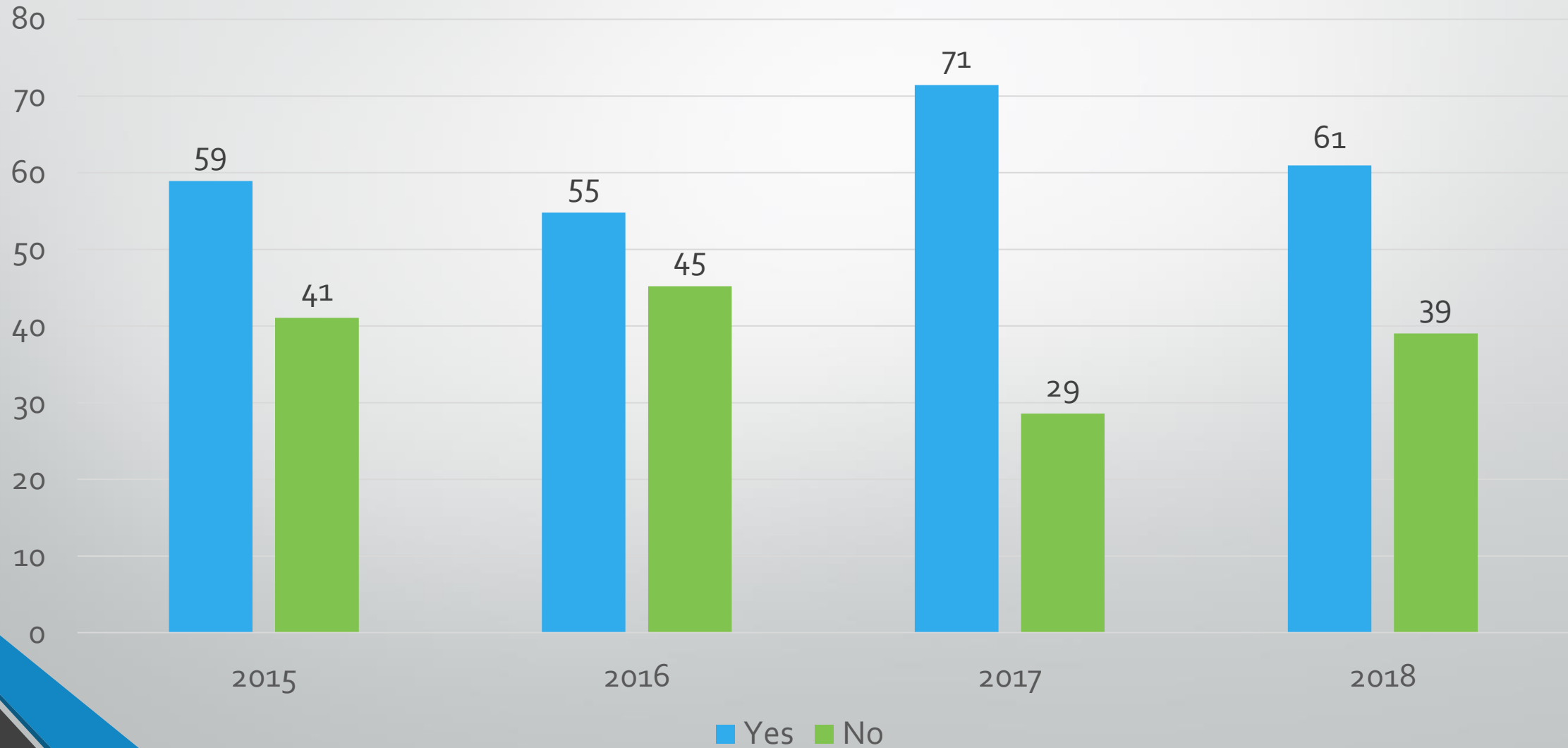
B7.1. DOES YOUR INSTITUTION USE ECTS GRADE DISTRIBUTION TABLES?

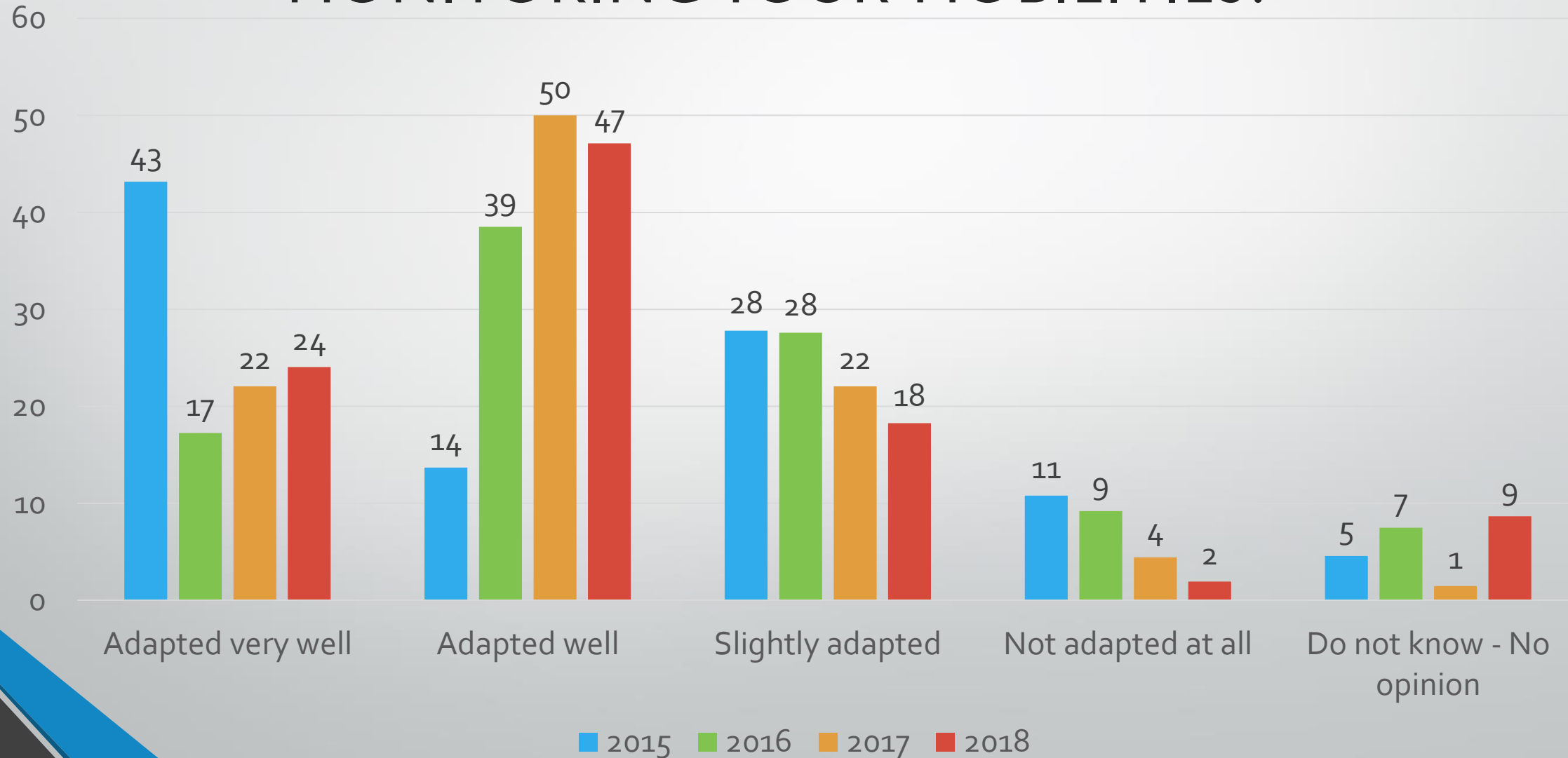

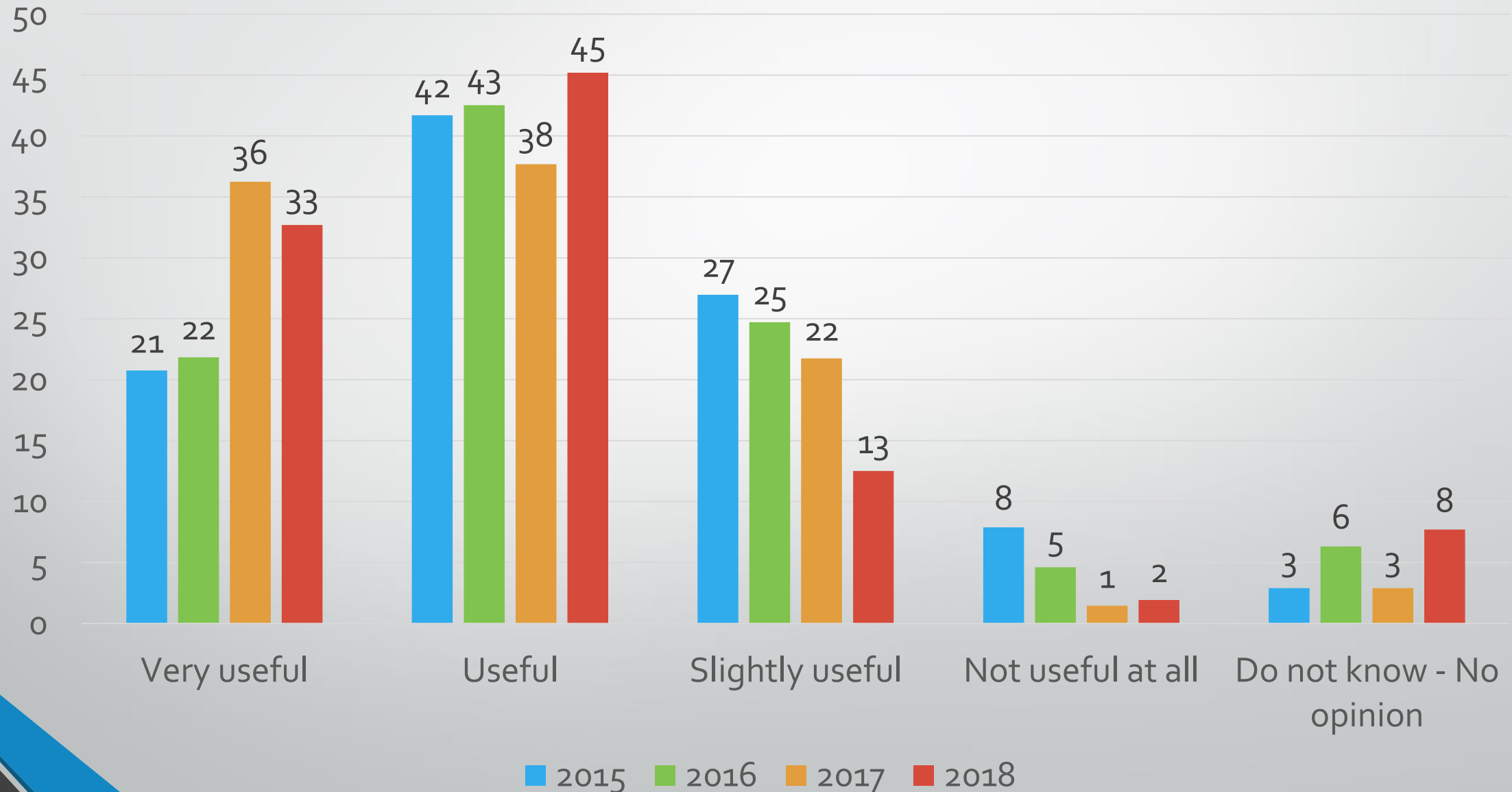

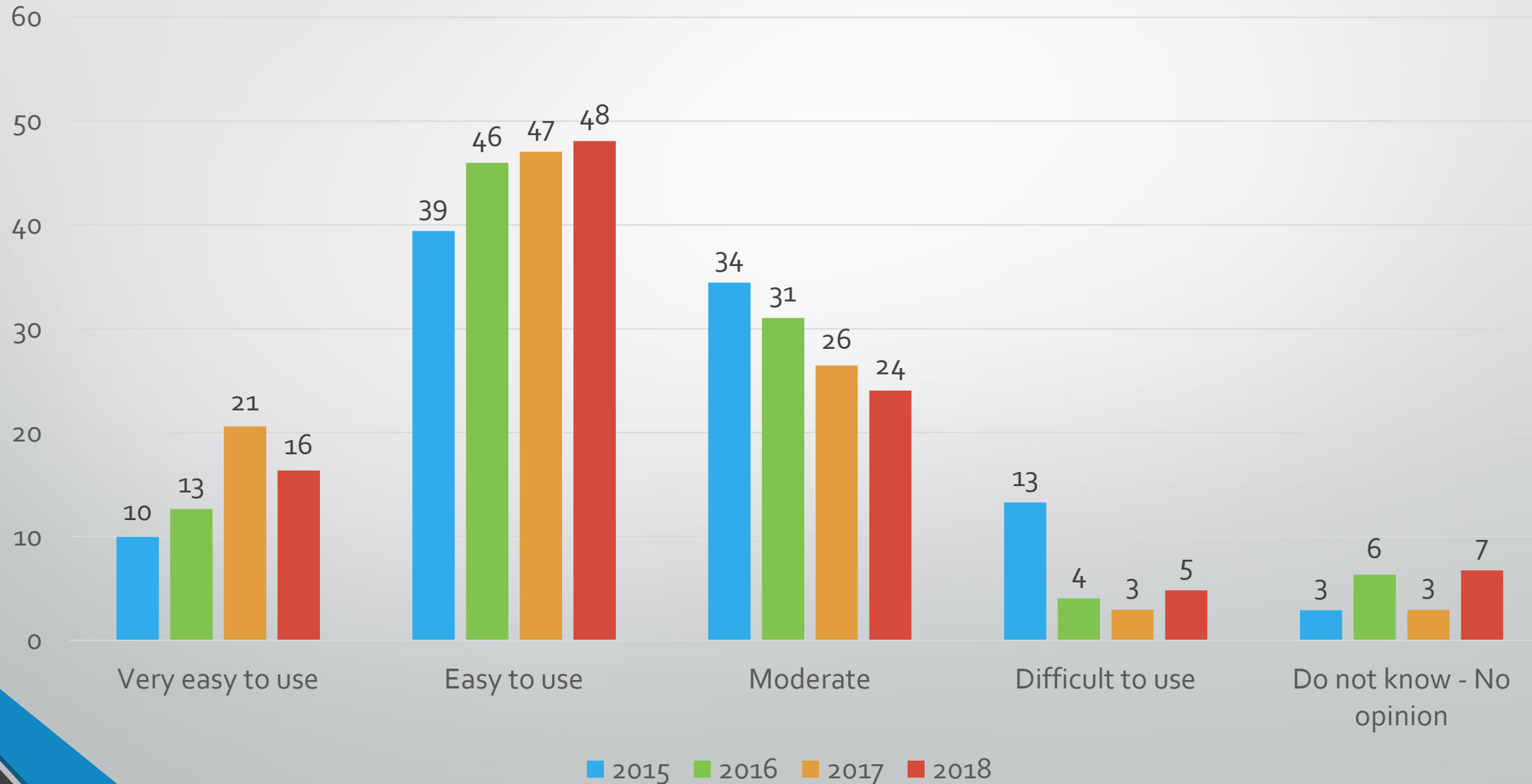

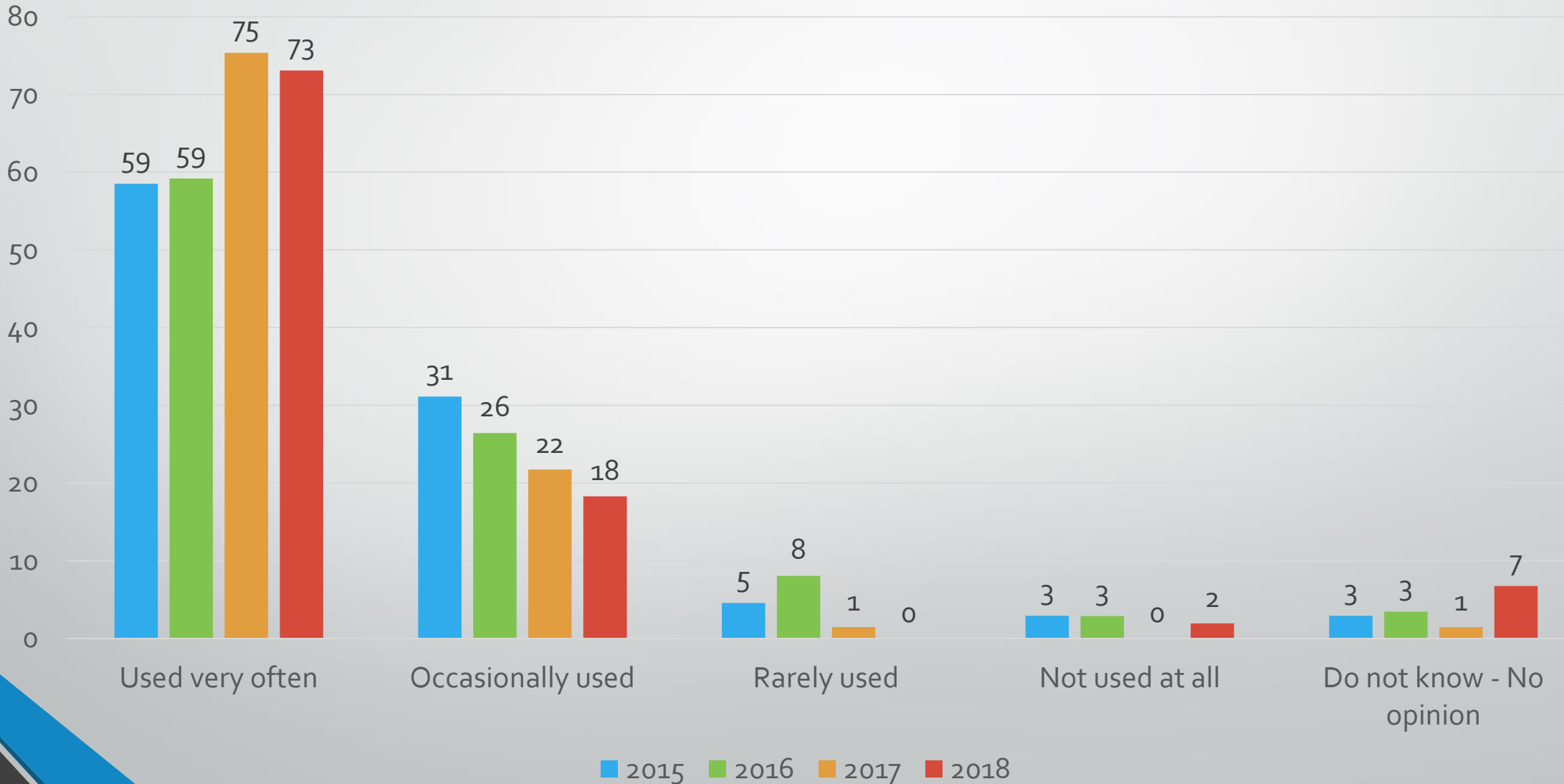

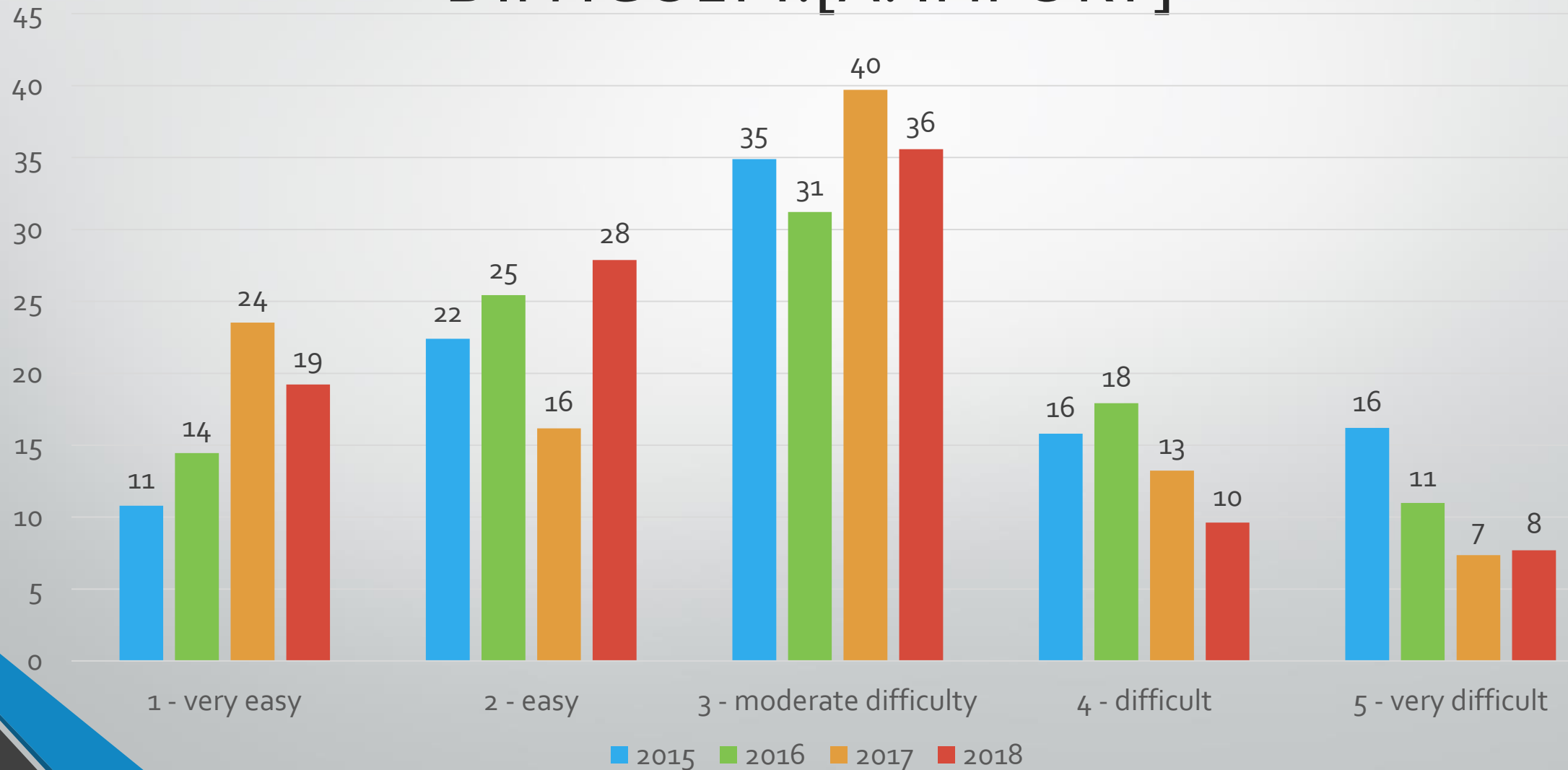

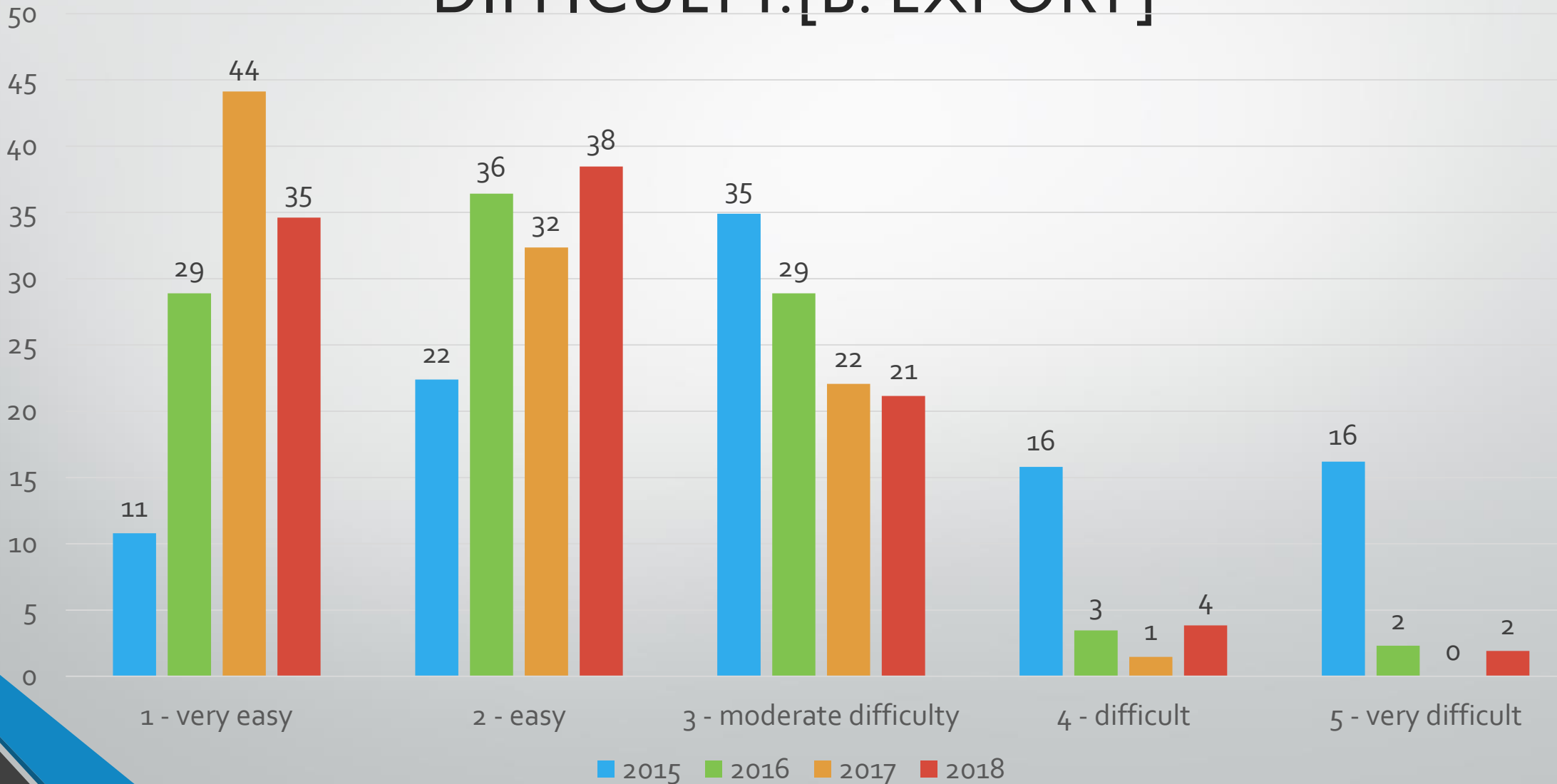
B8.4. IS THE MOBILITY TOOL+ USED AT YOUR INSTITUTION ON A REGULAR BASIS?



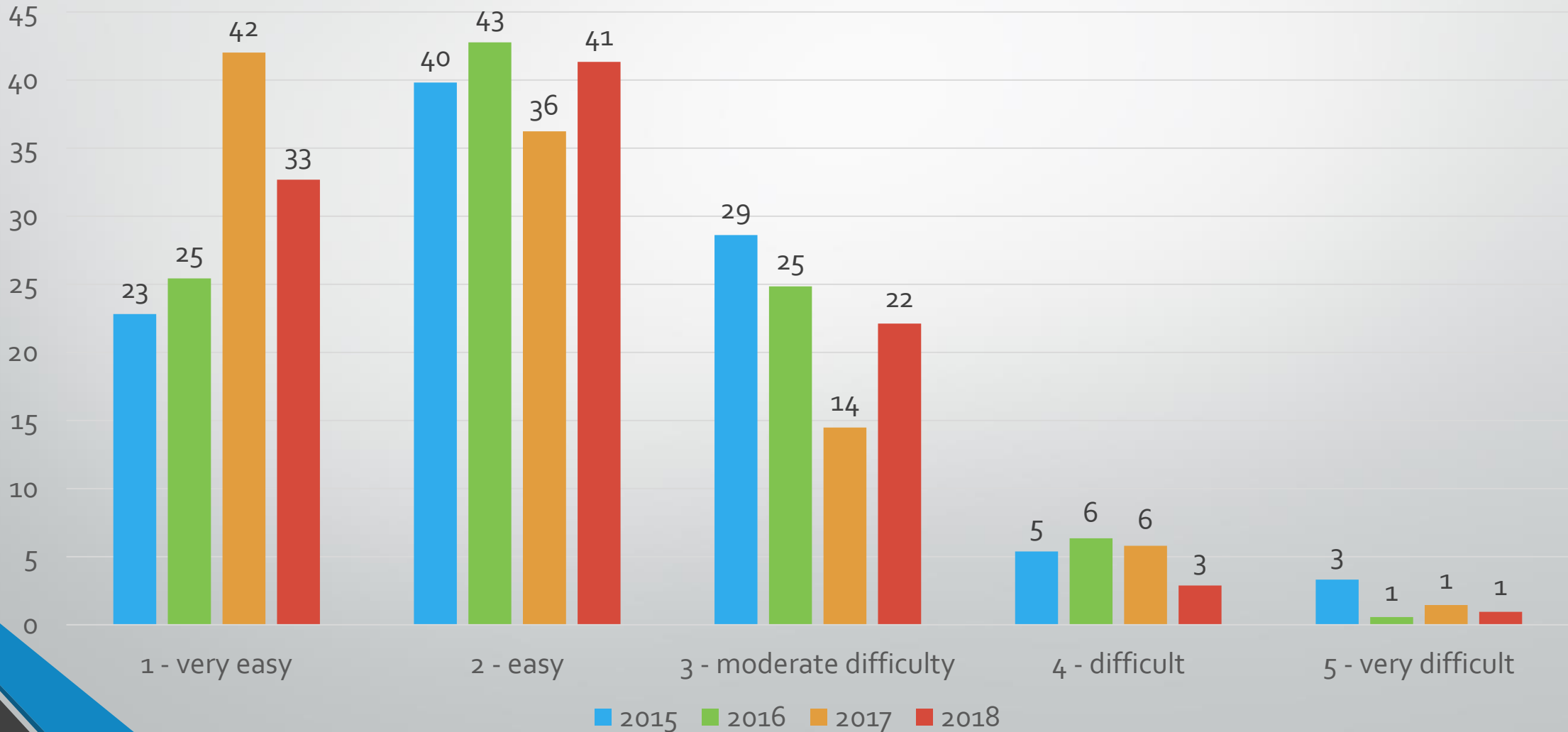

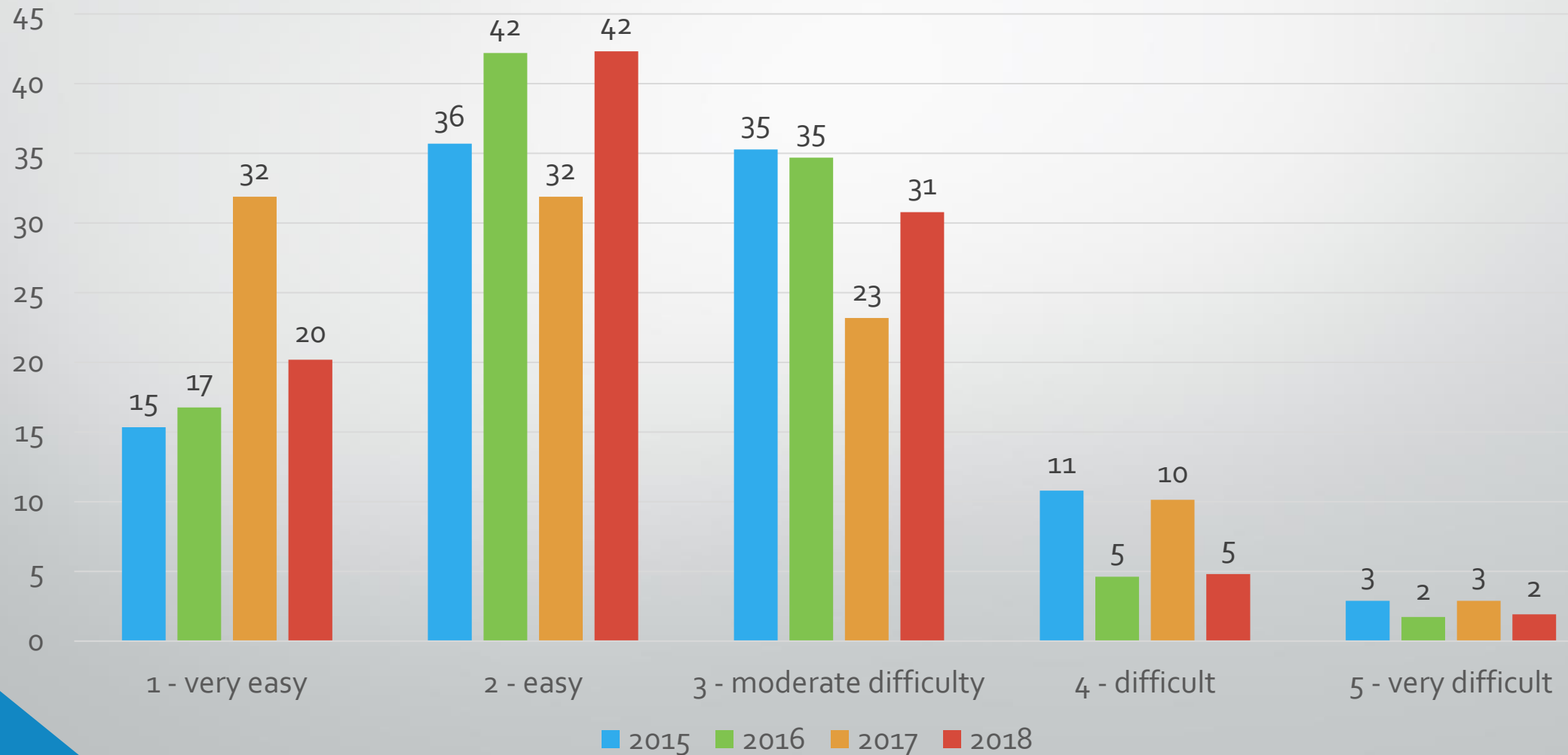

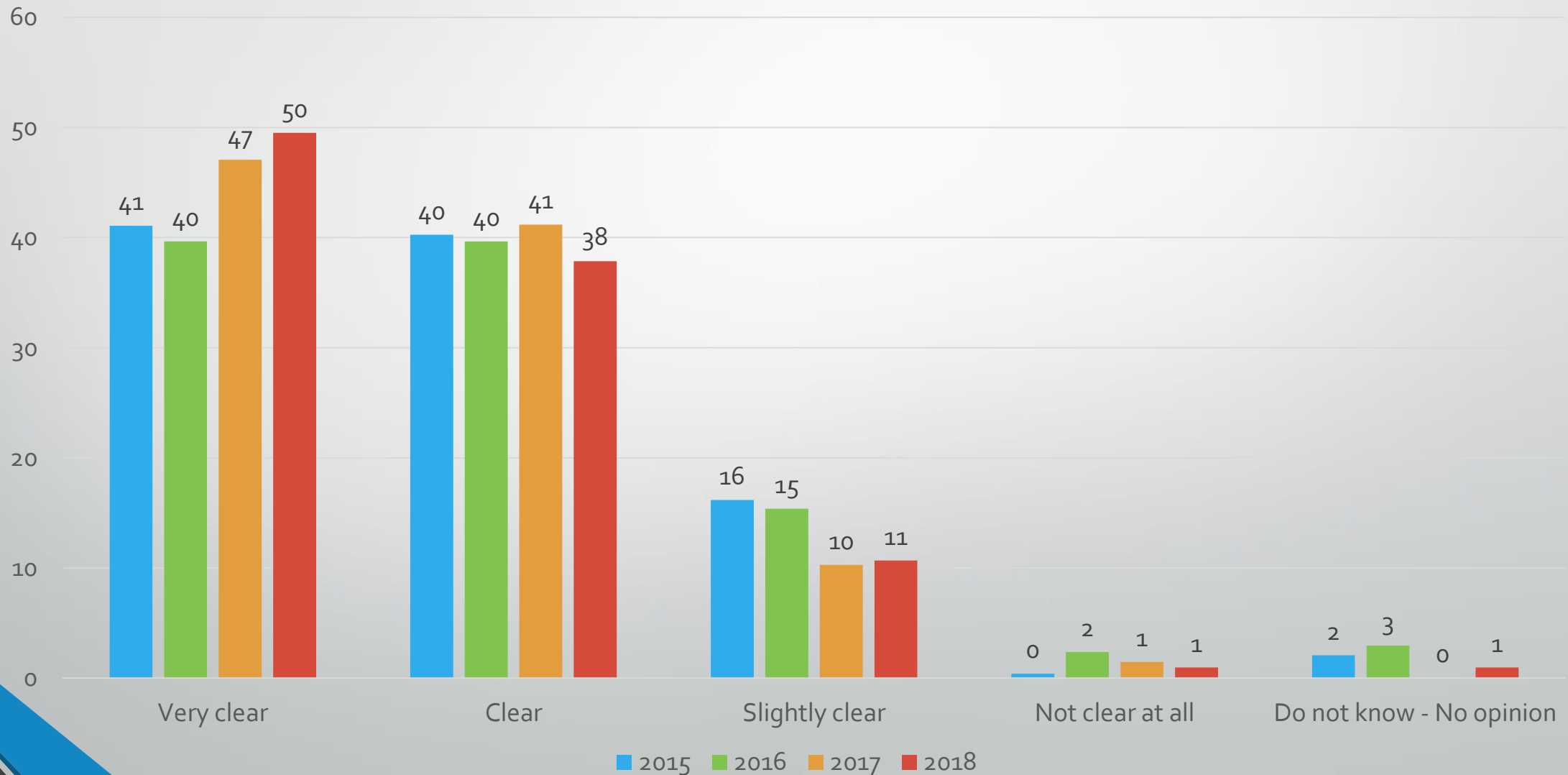

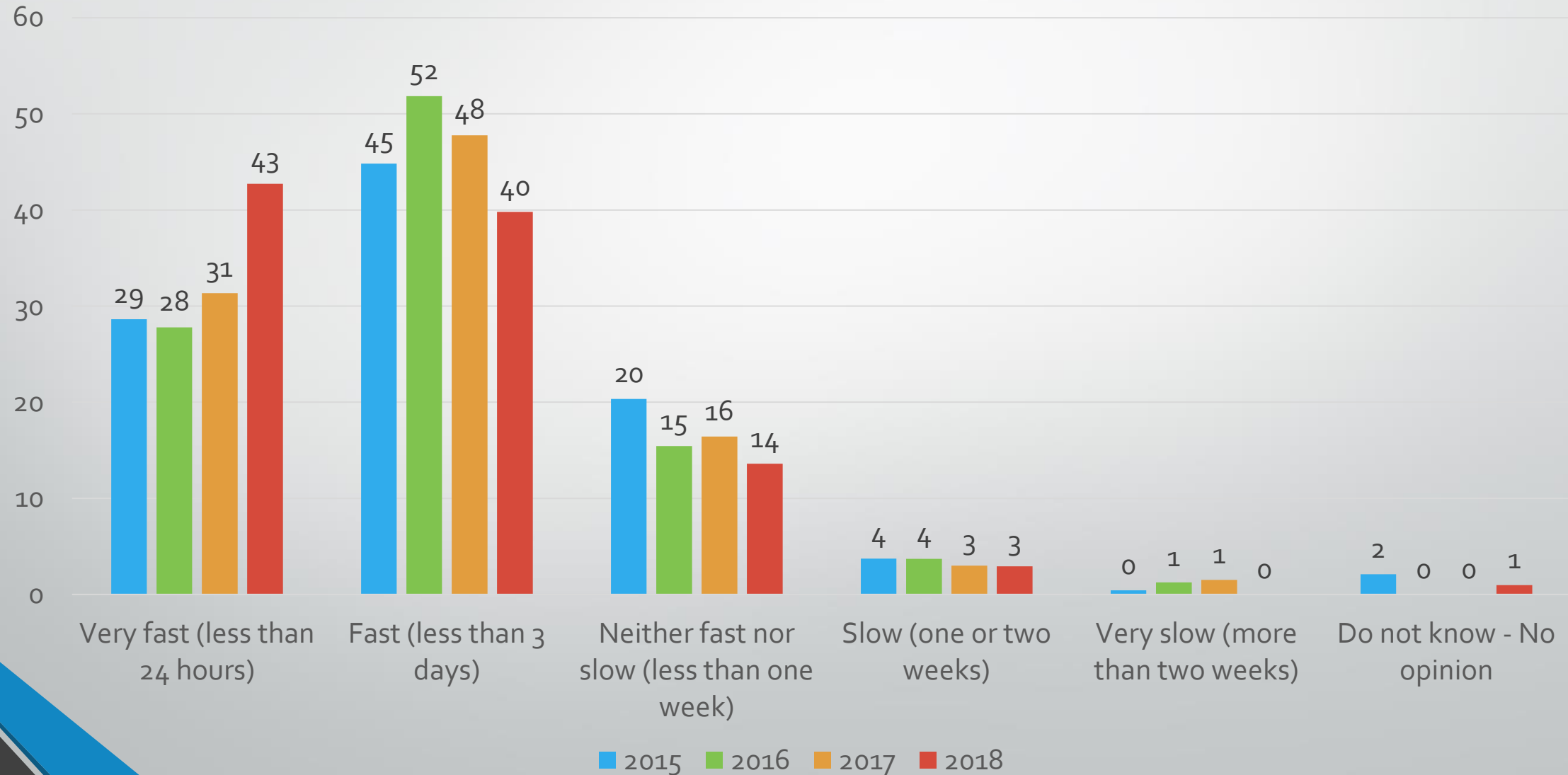

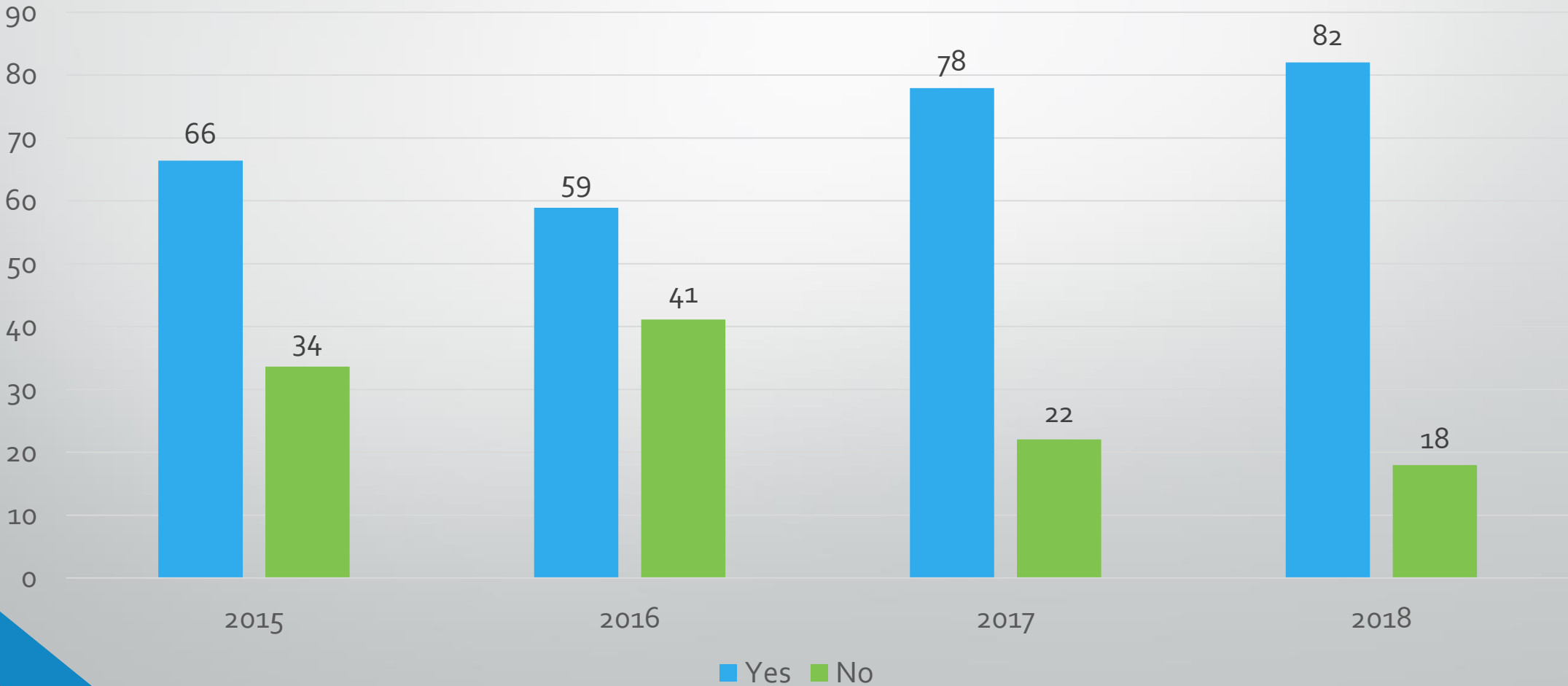
B9.4. DO YOU GET FAST RESPONSES FROM YOUR NATIONAL AGENCY?



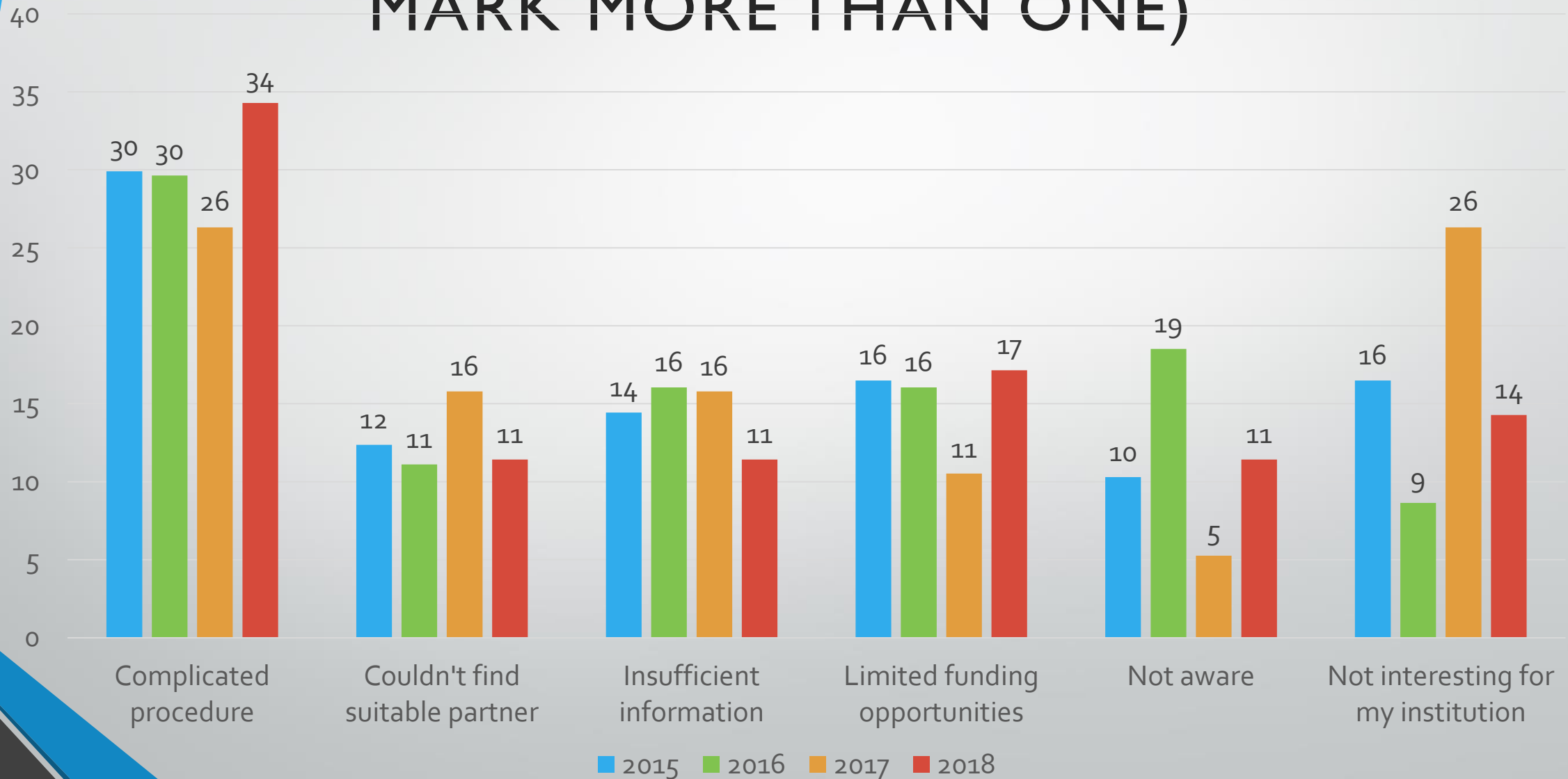

CI.3. DID YOU APPLY UNDER THE 2017 CALL FOR INTERNATIONAL CREDIT MOBILITY?

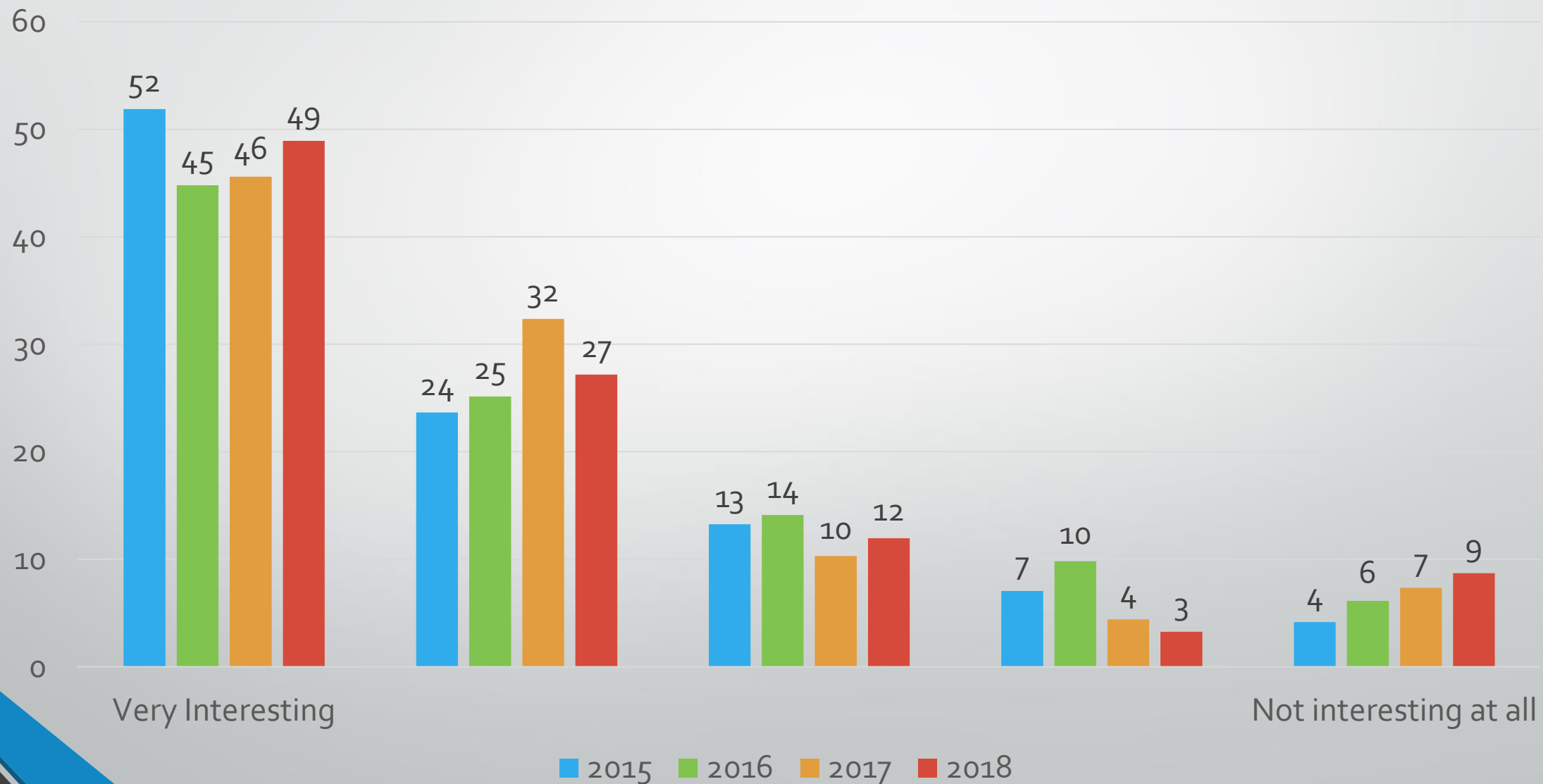

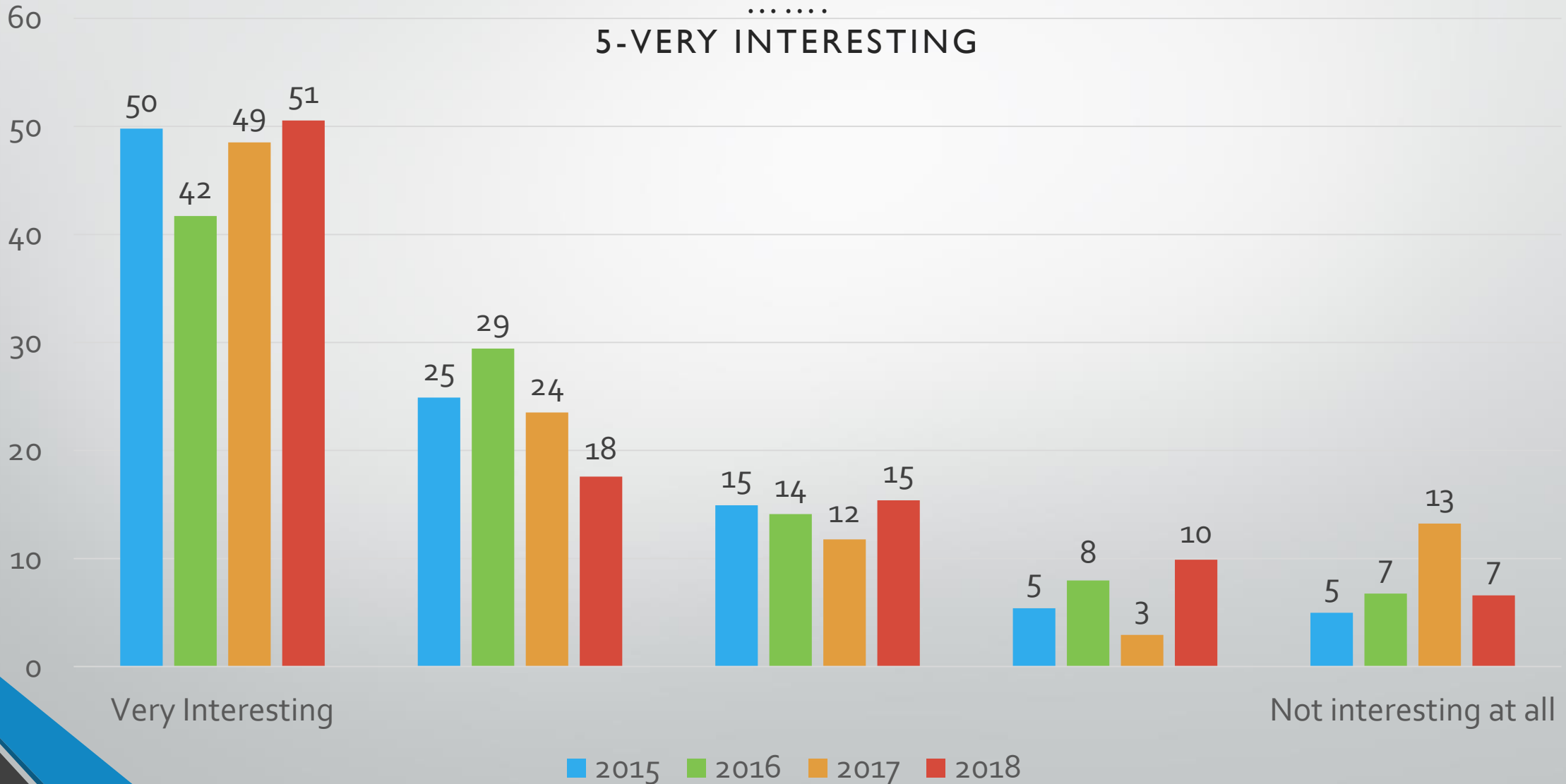

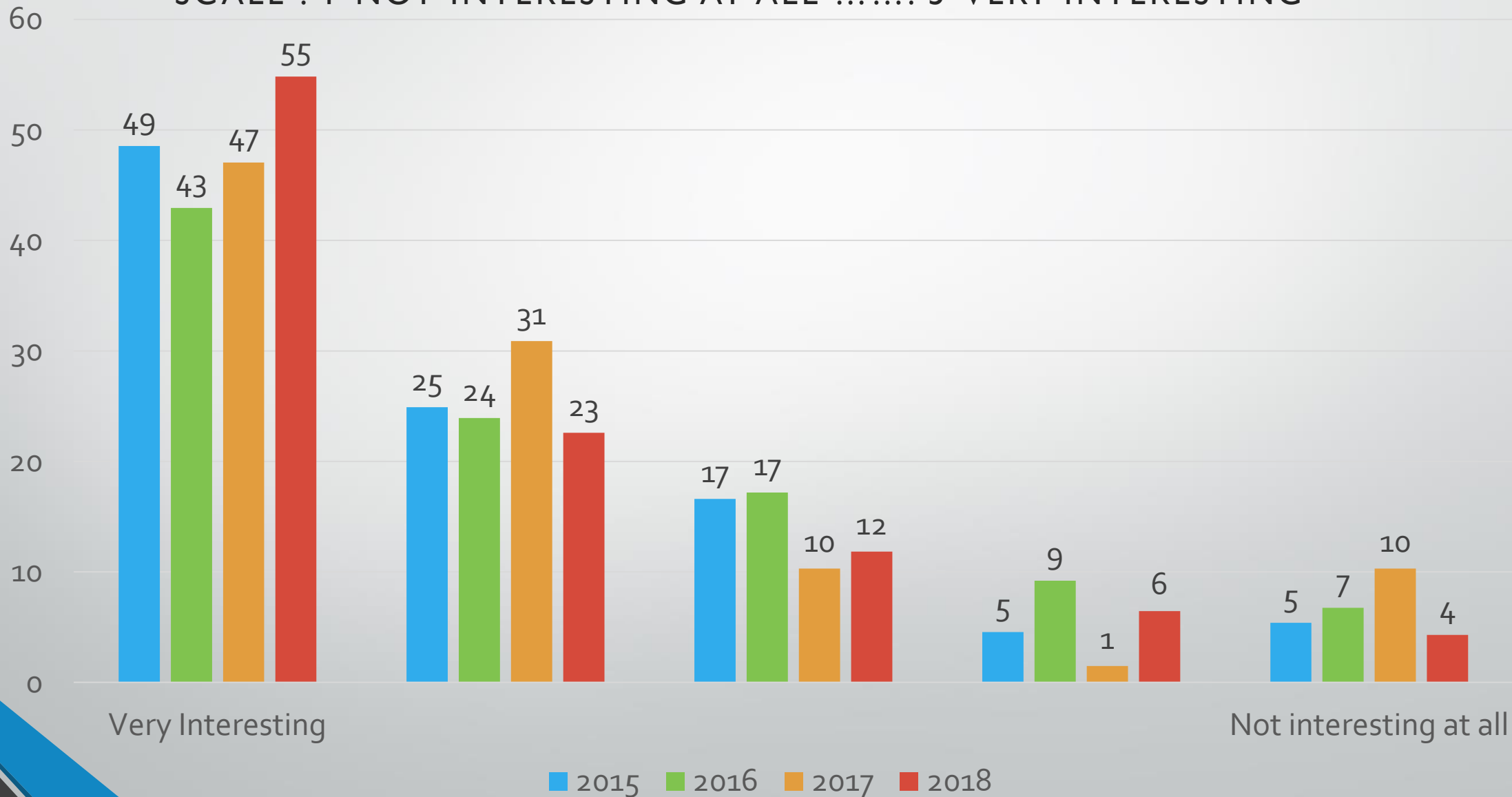

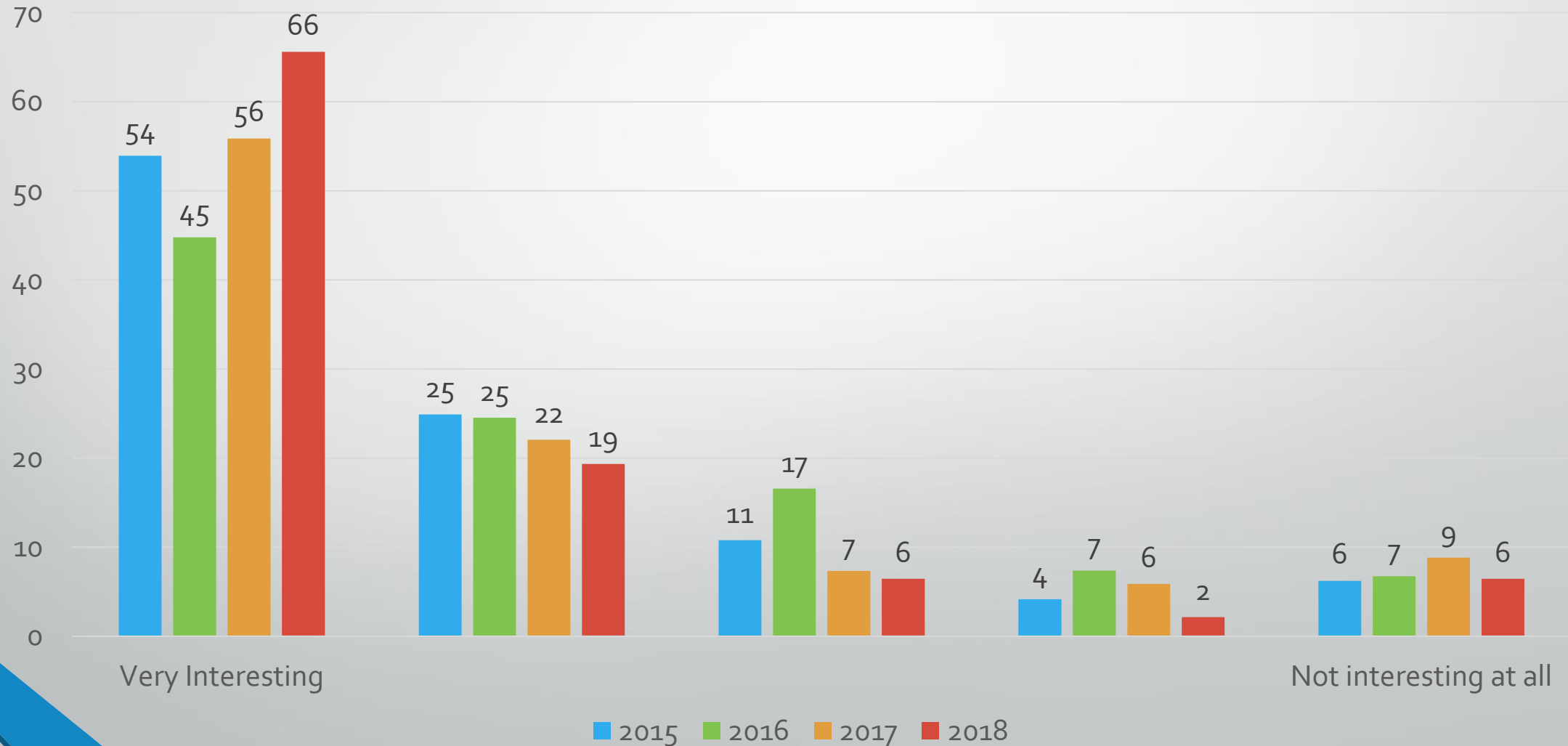

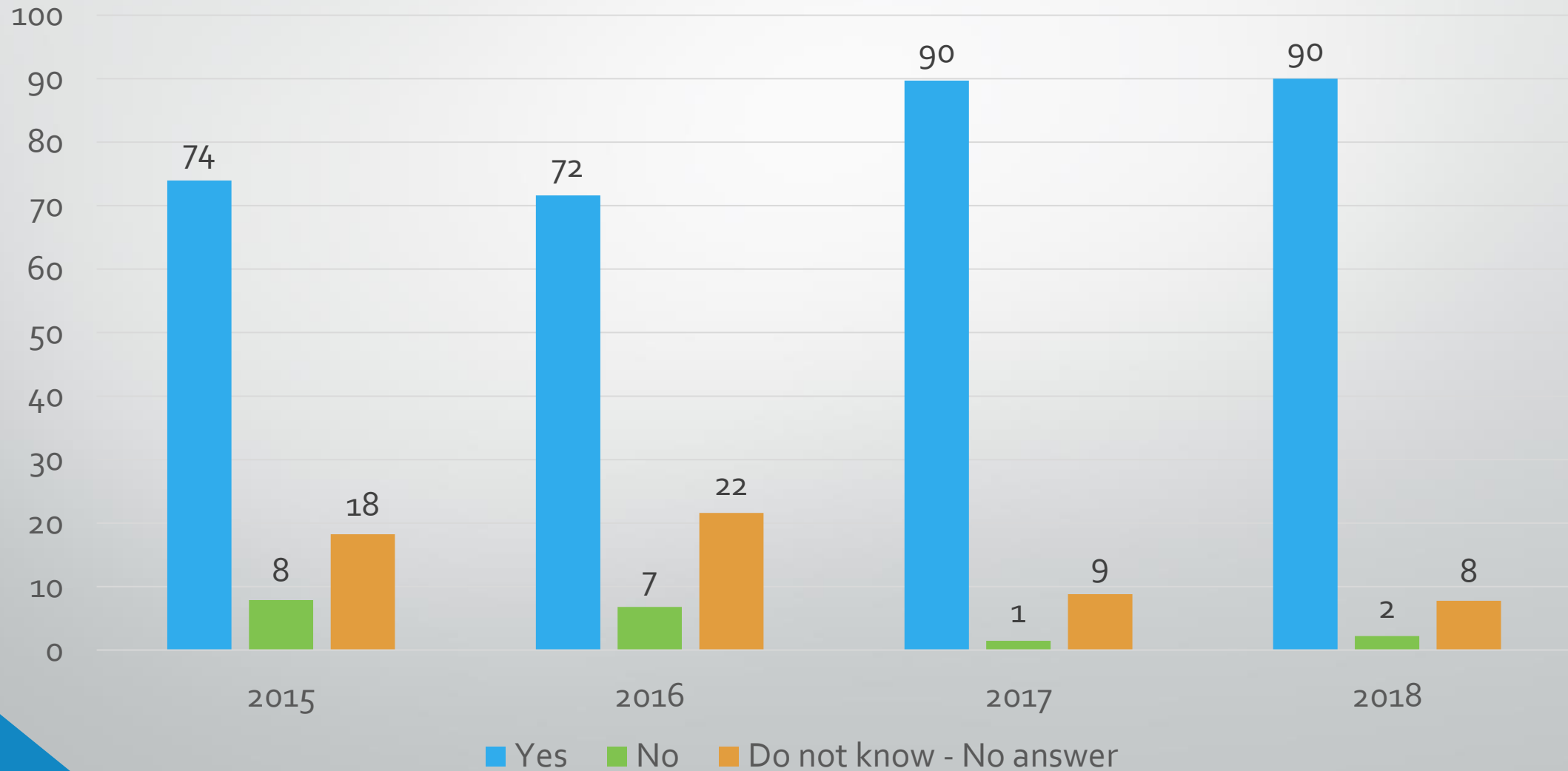

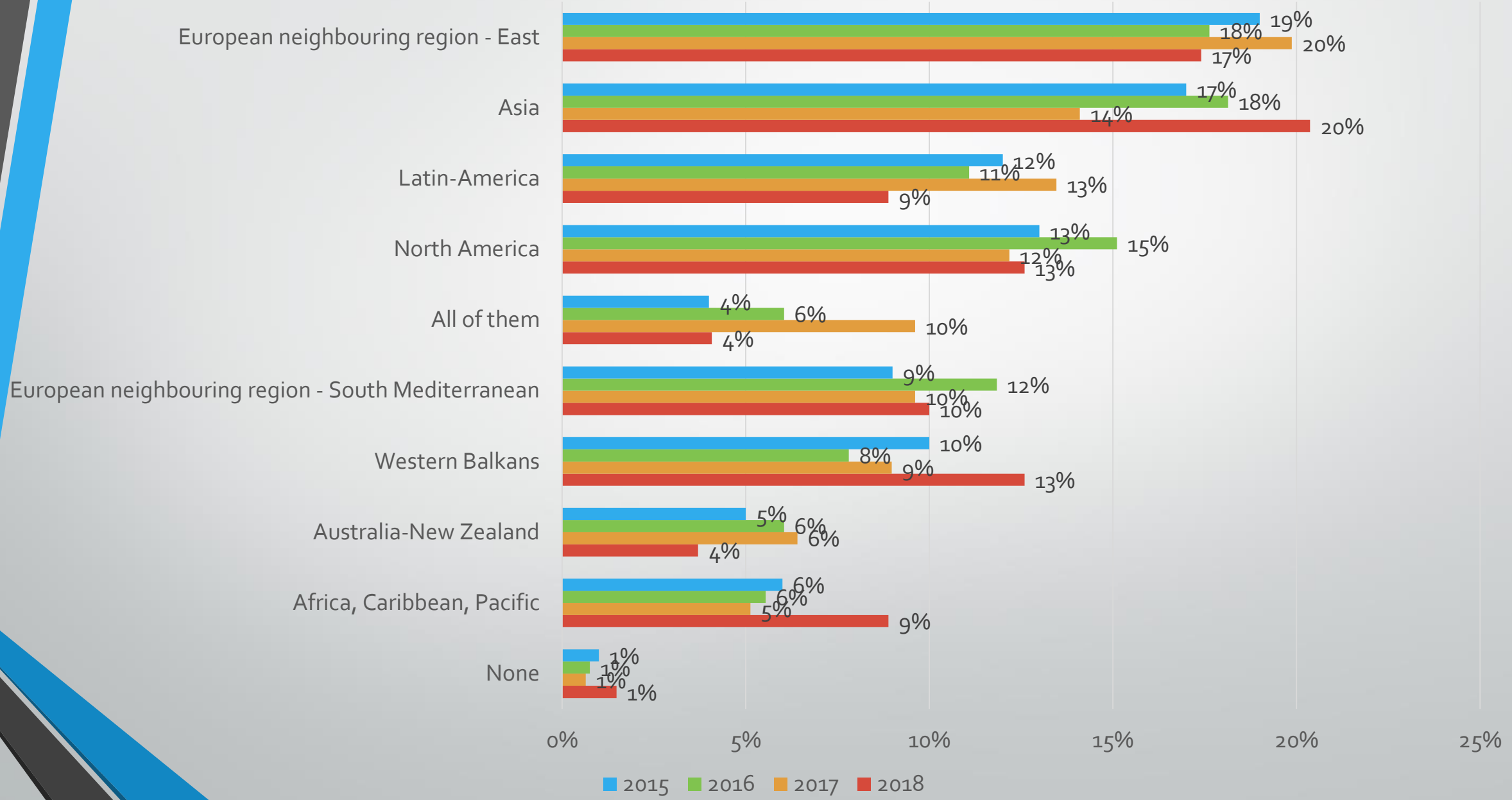

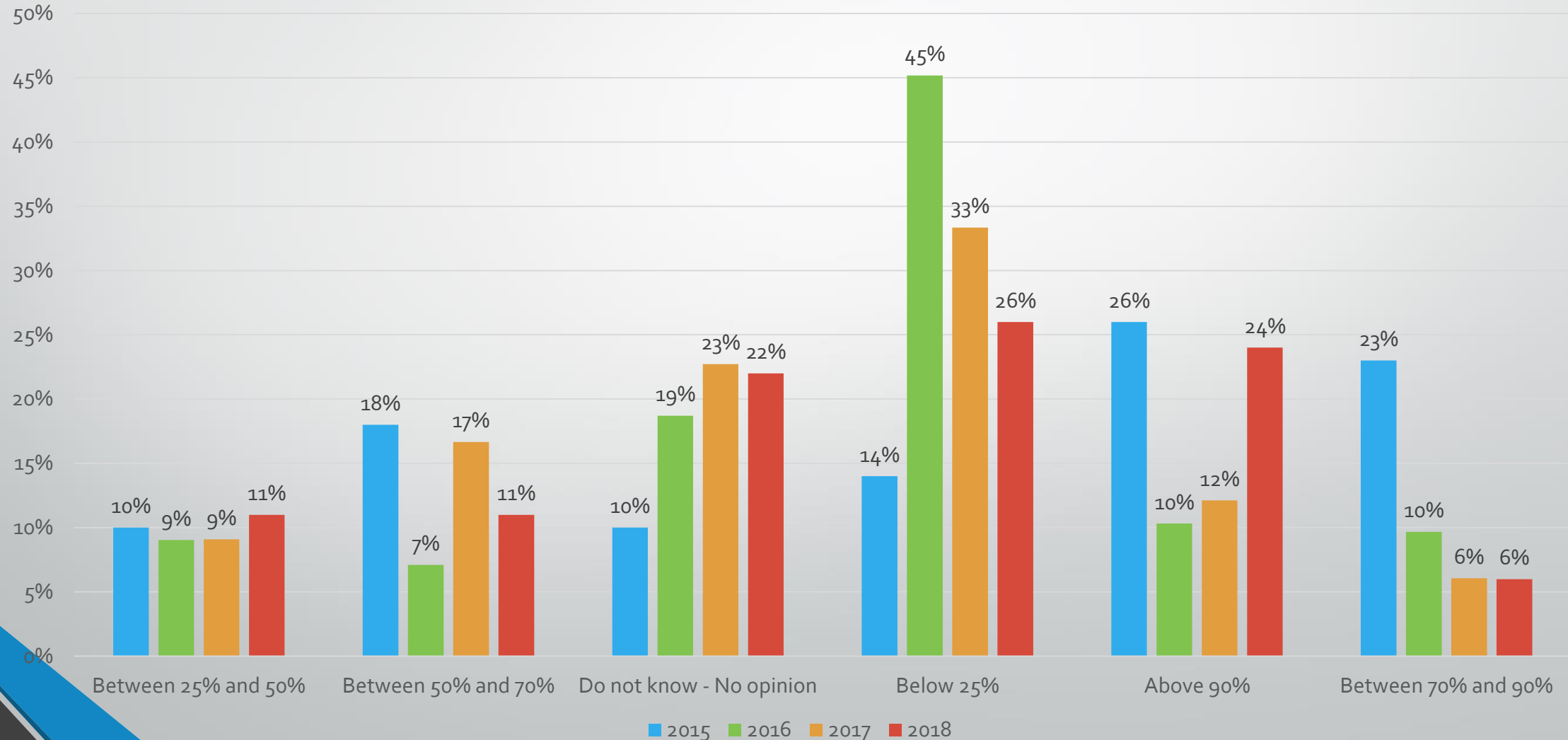
CI.8. WHICH REGIONS ARE MOST RELEVANT FOR YOU TO COOPERATE WITH?
